GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Proclamation under section 2 of the Audit Act 2008

This proclamation fixes 1 March 2009 as the day on which the *Audit Act 2008* commences. The proclamation also has the effect of commencing the *Audit (Consequential Amendments) Act 2008*, other than section 4 and Schedule 2, on the same day.

(2) Electricity Industry Safety and Administration (Energy Efficiency) Regulations 2009

These regulations -

(a) prescribe minimum standards of energy efficiency and performance for certain electrical articles; and

(b) provide for the marking and labelling of certain electrical articles to indicate energy efficiency; and

(c) are made consequentially on the repeal of the *Electricity Industry Safety and Administration Regulations 1999* under section 11 of the *Subordinate Legislation Act 1992*.

(3) Plumbers and Gas-fitters Registration Regulations 2009

These regulations, which are made consequentially on the rescission of the *Plumbers and Gas-fitters Registration Regulations 2004* under the *Occupational Licensing Act 2005* –

(a) provide for the allowances and accounts of the Plumbers and Gas-fitters Registration Board; and

(b) provide for a range of matters relating to registrations under the *Plumbers and Gas-fitters Registration Act* 1951 including fees, forms and application requirements; and

(c) rescind the *Plumbers and Gas-fitters Registration Amendment Regulations 2008.*

(4) Proclamation under section 2 of the Wills Act 2008

This proclamation fixes 1 March 2009 as the day on which the Wills Act 2008 commences.

(5) Sewers and Drains (George Town Limited Sewerage District) Order 2009

This order-

(a) appoints, defines and names the George Town Limited Sewerage District; and

(b) declares the purpose of that district; and

(c) revokes previous orders relating to that district.
