GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Threatened Species Protection Order 2011*

This order amends the *Threatened Species Protection Act 1995* by –

- (a) adding certain species to, and omitting certain species from, the Schedules of endangered, vulnerable and rare flora and fauna; and
- (b) updating certain taxonomic, authority, family, order and common name references in the Schedules.

(2) *Probate Amendment Rules 2011*

These Rules of Court amend the *Probate Rules 1936* by –

- (a) increasing the fees payable to the Registrar of the Supreme Court in non-contentious proceedings under the *Administration and Probate Act 1935* and rescinding the provisions relating to the costs, charges and disbursements allowed to solicitors in those proceedings; and
- (b) updating certain references consequent on the enactment of the *Legal Profession Act 2007*; and
- (c) amending Form XXII relating to the Administrator's Oath.
