PUBLIC NOTICE - DATES OF CLOSING OF THE COMMERCIAL ABALONE FISHERY IN STATE WATERS OFF THE COAST OF THE FURNEAUX GROUP, SOUTHPORT, THE FREYCINET PENINSULA, AND THE NORTH-EAST OF TASMANIA

I, GRANT PULLEN, Acting Director (Marine Resources), acting under Rule 9 of the *Fisheries (Abalone) Rules 2009*, and delegated authority under Section 20(1) of the *Living Marine Resources Management Act 1995*, hereby determine:

that the dates of the closed season for the commercial greenlip abalone fishery for the taking of greenlip abalone (*Haliotis laevis*) for commercial purposes from State waters off the coast of the Furneaux Group are as follows:

- from 28 November 2011 to 31 December 2011, inclusive; and

that the dates of the closed season for the commercial blacklip abalone fishery for the taking of blacklip abalone (*Haliotis rubra*) for commercial purposes from State waters off the coast of Southport, the Freycinet Peninsula, and the north-east of Tasmania, and the dates of the closed season for the commercial greenlip abalone fishery for the taking of greenlip abalone (*Haliotis laevis*) for commercial purposes from State waters off the coast of the north-east of Tasmania are as follows:

- from 5 December 2011 to 31 December 2011, inclusive;

where: "**Furneaux Group**" is defined to mean: those State waters within an area bounded in the east by the line of longitude at 148° 35' 36.2" East, in the west by the line of longitude at 147° 37' 21.9" East, in the north by the line of latitude at 39° 35' 14.9" South, and in the south by the line of latitude at 40° 38' 24.1" South;

"**Southport**" is defined to mean: those State waters within an area bounded in the south by the line of latitude at 43° 30' 45.32" South, and bounded in the east by the line of longitude at 147° 04' 20.36" East, and bounded in the north by the line of latitude at 43° 18' 10.64" South, and bounded in the west by the line of longitude at 146° 53' 49.76" East;

"**Freycinet Peninsula**" is defined to mean: those State waters within an area bounded in the south by the line of latitude at 42° 30' 33.27" South, and bounded in the east by the line of longitude at 148° 35' 46.01" East, and bounded in the north by the line of latitude at 41° 43' 18.24" South, and bounded in the west by the line of longitude at 147° 55' 12.44" East; and

"**the north-east**" is defined to mean: those State waters off the north-east coast of Tasmania within an area bounded in the west by an imaginary line beginning where the line of longitude 147° 27' 00" East meets the high-water mark of the north coast of the mainland of Tasmania in Anderson Bay, then running due north until its junction with the line of latitude 40° 39' South, then due east along that line of latitude to the limit of State waters, and bounded in the east by an imaginary line from the northern side of the mouth of the Great Musselroe River at Musselroe Bay running due west for 100 metres, then following the shoreline 100 metres from shore to the northernmost tip of Musselroe Point, then running due north until intersection with the line of latitude 40° 48' 00" South, and running due east to the outer limit of State waters.

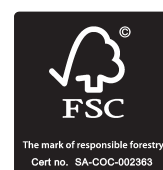
