NOTIFICATION OF EXEMPTION

Work Health and Safety Regulations 2012

Workplace Standards Tasmania Hobart, 11 September 2013

I, MARTIN EDMUND SHIRLEY, General Manager, WorkSafe Tasmania, Department of Justice, as the Regulator under the *Work Health and Safety Act 2012*, grant a class exemption under regulation 684 of the *Work Health and Safety Regulations 2012* for all inflatable amusement devices of less than three metres platform height from design or item registration, annual inspection and additional requirements in Part 5.2 of the *Work Health and Safety Regulations 2012*.

In addition, the professional engineer requirements in regulation 241(5)(a)(ii) does not apply to 'inflatable structures or devices (continuously blown)' with a platform height between three and nine metres if the annual inspection is conducted by a competent person.

Exemption decision:

Exemption approved.

Exemption applies to:

This exemption applies to the class of persons to whom regulation 241(5)(a)(ii), 243 and 246 of the *Work Health and Safety Regulations 2012* applies (the 'duty holder'). The duties covered by these regulations are–

• The annual inspection of amusement devices by a person who:

(a) either-

(i) has the skills, qualifications, competence and experience to inspect the plant; and

- (ii) is-
 - (A) registered on the National Professional Engineers Register administered by the Institution of Engineers, Australia; or
 - (B) a member of the Institution of Engineers, Australia with the status of Chartered Professional Engineer; or

(b) is determined by the regulator to be a competent person.

- The design of an item of plant specified in schedule 5, Part 1 must be registered; and
- An item of plant specified in schedule 5, Part 2 must be registered to ensure that it is inspected by a competent person and is safe to operate.

The work or thing to which this exemption applies to is:

- (1) The exemption of all inflatable amusement devices of less than three metres platform height from:
 - item or design registration (regulation 243 and 246);
 - annual inspection (regulation 241); and
 - any additional requirements in Part 5.2 of the *Work Health* and Safety Regulations 2012.
- (2) The professional engineer requirement in regulation 241(5)
 (a)(ii) so that this requirement does not apply to 'inflatable structures or devices (continuously blown)' with a platform height between three and nine metres if the annual inspection is conducted by a competent person.

'Platform height' means the height of the highest part of the inflatable amusement device designed to support persons who use the amusement structure or device, as measured from the supporting ground to the top surface of the platform on the inflated, but unloaded, structure or device.

The circumstance in which this exemption applies is: This exemption will apply immediately upon gazettal.

This exemption applies to:

- Regulation 241(5)(a)(ii) of the Work Health and Safety Regulations 2012;
- Item 1.8 of clause 1 of Part 1 of Schedule 5 of the *Work Health and Safety Regulations 2012*;
- Item 3.6 of clause 3 of Part 2 of Schedule 5 of the *Work Health and Safety Regulations 2012.*
