SCHEDULE

Section 11 Exemption Order

WATERCOURSE AUTHORITIES WITHIN SPECIFIED IRRIGATION DISTRICTS

I, JEREMY ROCKLIFF, Minister for Primary Industries and Water, acting pursuant to Section 11 of the *Water Management Act 1999* hereby exempt all dam owners located within the following Irrigation Districts:

- (1) River Clyde Irrigation District;
- (2) Cressy Longford Irrigation Water District;
- (3) Lake Leake/Elizabeth/Macquarie River Irrigation District; and
- (4) Tooms Lake/Macquarie River Irrigation District;

who wish to convey stored water via any watercourse located within the irrigation district to a water user within the same Irrigation District from obtaining a Watercourse Authority under Part 6A of this Act, subject to the following conditions:

This exemption takes effect on the day upon which it is gazetted and remains in force for a period of 2 years unless otherwise revoked.
