TASMANIAN HEALTH ORGANISATIONS ACT 2011

NOTICE OF TRANSFER OF PROPERTY, RIGHTS, LIABILITIES AND OBLIGATIONS OF THE CROWN TO THE TASMANIAN HEALTH SERVICE

I, Michael Darrel Joseph Ferguson MP, being and as the Minister for Health, acting pursuant to section 81 and clause 4 of Schedule 6 of the *Tasmanian Health Organisations Act 2011* (the Act), transfer the property, rights, liabilities and obligations of the Crown specified in the Schedule to this notice to the Tasmanian Health Service, with effect from 12.00 am on 1 January 2017 (the Transfer Day):

Schedule

1 • Property and Rights

- (a) Cash and deposits held by the Crown as at 11.59 pm on 31 December 2016 in special purpose trust accounts solely relating to the Transferring Services.
- (b) Amounts prepaid by the Crown as at 11.59 pm on 31 December 2016 for goods and services {other than inventories} solely relating to the Transferring Services.
- (c) Inventories held by the Crown as at 11.59 pm on 31 December 2016 solely for the Transferring Services.
- (d) All plant and equipment owned by the Crown held, or used by or for the operation of, the Transferring Services as at 11.59 pm on 31 December 2016 but excluding any Excluded Property.
- (e) Accounts receivable (accrued but whether or not invoiced) by the Crown as at 11.59 pm on 31 December 2016 solely relating to the Transferring Services.
- (f) Doubtful debts held by the Crown as at 11.59 pm on 31 December 2016 solely relating to the Transferring Services.
- (g) Records in the custody of the Crown as at 11.59 pm on 31 December 2016 relating to the Transferring Services.

2. Liabilities and Obligations

- (a) A liability of the Crown relating to the Transferring Services in respect of any amount prepaid by any person to the Crown for the delivery of any goods or services to that person by the Crown on or after the Transfer Day.
- (b) A liability (accrued but whether or not invoiced) of the Crown relating to the Transferring Services in respect of any trade creditors and accruals as at 11.59 pm on 31 December 2016.
- (c) Accrued salaries relating to the Transferring Services as at 11.59 pm on 31 December 2016.

3. Interpretation

In this notice:

Excluded Property means:

- (a) any fixtures to land or buildings; and
- (b) information and communication technology plant, equipment and software used to operate information technology systems.

Records means documents or objects that are, or that have been, made or kept by reason of any information or matter that they contain or that can be obtained from them by reason of their connection with any event, person, circumstance, or thing.

Transferring Services means the Department of Health and Human Services' unit known as Child Health and Parenting Services as structured at 11.59 pm on 31 December 2016.

Unless a contrary intention is apparent, words or phrases or terms defined in the Act have meanings given to them in the Act.
