## Threatened Species Protection

### Preliminary Recommendations of the Scientific Advisory Committee (Threatened Species)

IN ACCORDANCE with Section 18 of the *Threatened Species Protection Act 1995* it is hereby advised that the Committee has decided to recommend delisting the shade plantain (*Plantago debilis*) from Schedule 5, Part 2 (rare), delisting the humpback whale (*Megaptera novaeangliae*) from Schedule 3, Part 1 (endangered), delisting the cooks tussockgrass (*Poa cookii*) from Schedule 3, Division 2 (endangered), and delisting the prickly shieldfern (*Polystichium vestitum*) from Schedule 3, Division 2 (endangered). Interested parties are invited to provide any scientific information that relates to these species' conservation assessment to the Scientific Advisory Committee (Threatened Species) by email: [threatenedspecies.enquires@nre.tas.gov.au](mailto:threatenedspecies.enquires@nre.tas.gov.au) within 30 days of the date of this notice.





