Biosecurity

DECLARATION OF PROHIBITED MATTER

Biosecurity Act 2019

Section 20

- 1. I, Noel Carmichael, being and as the Acting Manager of the Invasive Species Branch of the Department of Natural Resources and Environment Tasmania (the Department), and delegate of the Minister for Primary Industries and Water, hereby declare pursuant to section 20 of the *Biosecurity Act 2019* ("the Act") the biosecurity matter or classes of biosecurity matter listed in **Schedule 1** below to be prohibited matter for the purposes of the Act, being satisfied that
 - (a) the biosecurity matter or classes of biosecurity matter pose a significant biosecurity risk to Tasmania; and
 - (b) the declaration is necessary to prevent, eliminate, minimise, control or manage the biosecurity risk posed by the biosecurity matter or class of biosecurity matter.
- 2. This declaration is subject to the following provisions:
 - (a) any biosecurity matter that becomes prohibited matter because of this declaration may be lawfully disposed of, treated or destroyed –
 - (i) in accordance with a prohibited matter permit issued under the Act; or
 - (ii) in accordance with any biosecurity direction issued under the Act; or
 - (iii) under the supervision or direction of an authorised officer;
 - (b) section 74 of the Act does not apply in respect of the disposal, treatment or destruction of any biosecurity matter under paragraph (a) above.
- 3. This declaration takes effect on the date of its publication in the Gazette and remains in force until revoked.

VETERINARY SURGEONS ACT 1987

Declaration of Veterinary Service Standards

PURSUANT to section 5B (1) of the *Veterinary Surgeons Act 1987*, the Veterinary Board of Tasmania hereby declares the following veterinary service standards:

- Standard 1. Expected behaviours and principles of professional conduct
- Standard 2. A primary concern for animal wellbeing
- Standard 3. Veterinary practitioner-owner-animal (VOA) relationship
- Standard 4. Communications between veterinary practitioner and the client or professional peers
- Standard 5. Provision of veterinary services outside normal business hours
- Standard 6. Veterinary premises, equipment, and assistance in the provision of veterinary services
- Standard 7. Veterinary medical records
- Standard 8. Veterinary practitioner and veterinary team wellbeing
- Standard 9. Practicing within areas of technical competence and continuing professional development (CPD)
- Standard 10. Managing conflict of interest (COI) and incitement to commit unprofessional conduct
- Standard 11. Referrals between veterinary practitioners
- Standard 12. Genetic disease
- Standard 13. Telemedicine and providing veterinary services across borders and to remote clients
- Standard 14. Supply and use of veterinary medications
- Standard 15. Responsible supply and use of antimicrobial agents (antibiotics)
- Standard 16. Biosecurity and infection control
- Standard 17. Veterinary certificates
- Standard 18. Practicing in accordance with statutory obligations and Board directions

The Standards apply to the rules of conduct and standards of service with which registered veterinary surgeons and veterinary specialists must comply. Standards 1 to 18 replace all previously declared veterinary service standards in full.
