#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Valuation of Land Regulations 2022*

These regulations –

- (a) prescribe, for the purposes of the *Valuation of Land Act 2001* –
  - (i) an amount by reference to which objections to valuations may be determined by the Supreme Court; and
  - (ii) the fee to be paid for a new valuation; and
  - (iii) the fee for a certified copy of an entry on a valuation roll; and
  - (iv) the fee for a certified copy of a certificate of new valuation; and
- (b) are made consequentially on the repeal of the *Valuation of Land Regulations 2012* under section 11 of the *Subordinate Legislation Act 1992*.

(2) *Valuation of Land (Tender Committee) Regulations 2022*

These regulations –

- (a) prescribe the procedure to be followed at meetings of the tender committee appointed to assess tenders for a fresh valuation for a valuation district; and
- (b) are made consequentially on the repeal of the *Valuation of Land (Tender Committee) Regulations 2012* under section 11 of the *Subordinate Legislation Act 1992*.

(3) *Taxi Industry Amendment (Remote Electronic Updates) Regulations 2022*

These regulations amend the *Taxi Industry Regulations 2018* by –

- (a) updating certain provisions to allow for remote electronic updates to be made to taximeters, and notifications to be given in relation those updates; and
- (b) rescinding certain amendment instruments, the contents of which have been incorporated into the principal regulations.

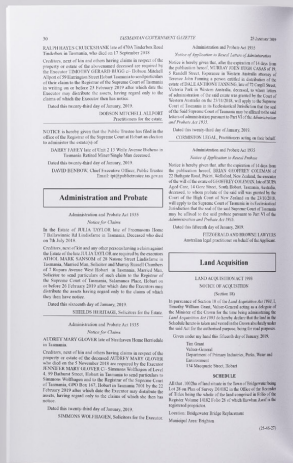
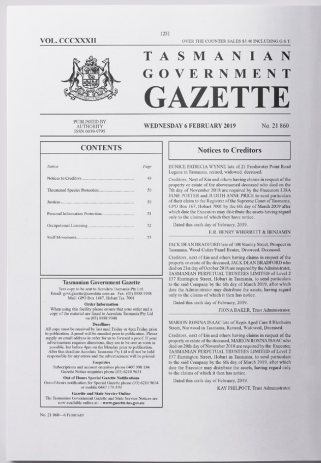
