Cat Management

CAT MANAGEMENT ACT 2009

Declaration of a Cat Management area under the Cat Management Act 2009

In accordance with Section 21A of the *Cat Management Act 2009* (The Act), Council hereby notifies the public of the declaration under Section 20 of the Act declaring an area of land within the Brighton municipality to be a cat management area.

The area of land that is to be declared a cat management area is 593-595 Briggs Road, Brighton ie Bonorong Wildlife Sanctuary. Trapping of cats found within the declared cat management area may occur at any time during the declared period.

Cat traps, that are set, will be checked regularly and the following measures may be taken for a cat caught in a cat trap within the declared cat management area:

- Detained and taken to Ten Lives cat management facility.
- Humane destruction of feral cats
- Humane destruction of any cat previously trapped within the cat management area, that is deemed to be a threat to the wildlife being kept at Bonorong Wildlife Sanctuary.

Bonorong Wildlife Sanctuary staff will be responsible to undertake the measures listed above.

The declaration will take effect on 17 June 2023 and will remain in force until 17 June 2025.



GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Defamation Order 2023

This order, for the purposes of section 35(1) of the *Defamation Act 2005*, declares \$459 000 to be the maximum amount of damages for non-economic loss that may be awarded from 1 July 2023 in defamation proceedings.

(2) Gaming Control (Monitoring Operator) Regulations 2023

These regulations prescribe, for the purposes of the Gaming Control Act 1993 –

- (a) the core and regulated functions of a monitoring operator; and
- (b) those situations that are a major or minor change in the situation of a monitoring operator for the purposes of section 48Q of that Act; and
- (c) the fees payable by venue operators for the provision of core functions and regulated functions by the monitoring operator.
- (3) Gaming Control Amendment (Jackpot Increments) Regulations 2023

These regulations amend the *Gaming Control Regulations 2022* by providing for the adjustment of gross profit adjustments for the purposes of calculating the community support levy consequent on the commencement of the *Gaming Control Amendment (Future Gaming Market) Act 2021*.
