Energy Ombudsman

ENERGY OMBUDSMAN ACT 1998, SECTION 39

PURSUANT to s 39 of the *Energy Ombudsman Act 1998* (the Act), I revoke all Guidelines previously made under that section, and substitute the following Guidelines.

Guidelines Overview

These Guidelines have been prepared in accordance with s 39(1) of the Act, and relate to the processes to be followed in preparing a budget in respect of the costs of administering the Act.

The Guidelines are based on the principle expressed in s 39C(1) of the Act, that the costs of administering the budget are to be met by all energy entities in such proportions as are specified in the budget. The expression "energy entity" is defined in the Act to mean:

- (a) an electricity entity within the meaning of the *Electricity Supply Industry Act 1995*; or
- (ab) a retailer within the meaning of the National Retail Law (Tasmania); or
- (ac) an exempt seller within the meaning of the National Energy Retail Law (Tasmania); or
- (ad) a person to whom, or a person who sells electricity to which, section 23 of the *National Energy Retail Law (Tasmania) Act 2012* applies;
- (b) a gas entity within the meaning of the *Gas Act 2000*.

The apportionment of the budget is to be based on the payment of membership fees and complaint levies. Each entity is to pay a membership fee in accordance with Section 1 of these Guidelines, if demanded. The entity will also pay a complaint levy if one is payable in accordance with Section 2.

1. The Membership Fee

Each entity is to pay a membership fee of \$10, if demanded.

2. The Complaint Levy

The balance of the budget is to be apportioned between energy entities through the imposition of complaint levies.

The Ombudsman will calculate -

- (a) the aggregate number of complaints and enquiries received by the Ombudsman under the *Energy Ombudsman Act* during the previous calendar year; and
- (b) the percentage of that aggregate number which is attributable to complaints made against, or enquiries made in respect of, each of the energy entities.

Each entity is to pay a levy which represents the percentage of the balance of the budget which is equal to the percentage attributed to that entity in accordance with paragraph (b).

3. Costs to be included in the Budget

The budget will include the estimated costs of administering the Act in the forthcoming financial year.

If the Ombudsman anticipates that, for good reason, the budget for the current financial year will be exceeded, the amount of the excess may be added to the budget which is in preparation.

If the Ombudsman anticipates spending less than the budget for the current financial year, the anticipated surplus will be credited to the energy entities in proportion to their contributions to that budget. The fact that a surplus is anticipated will also be taken into account in the preparation of the new budget.

COVID-19 DISEASE EMERGENCY (MISCELLANEOUS PROVISIONS) ACT 2020

NOTICE UNDER SECTION 20

I, ELISE NICOLE ARCHER, the Attorney-General, in pursuance of section 20 of the *COVID-19 Disease Emergency (Miscellaneous Provisions) Act 2020*, at the request of the President of the Tasmanian Civil and Administrative Tribunal established under the *Tasmanian Civil and Administrative Tribunal Act 2020* ("the Act"), being of the opinion that the relevant emergency circumstances exist in relation to this notice and with the approval of the emergency manager, declare that –

- (a) in relation to proceedings conducted by the Tribunal, despite –
 - (i) section 81 of the Act, including proceedings conducted in accordance with section 152 of the Act; and
 - (ii) section 30 of the *Health Practitioners Tribunal Act 2010* –
to the extent that those provisions require that a proceeding must be open to members of the public, such a proceeding may be heard in the approved manner determined by the President of the Tribunal in accordance with section 20(2) of the *COVID-19 Disease Emergency (Miscellaneous Provisions) Act 2020*; and
- (b) unless the contrary intention appears, an expression used in this notice that is defined in the Act has the same meaning in this notice as it has in the Act.

LIVING MARINE RESOURCES MANAGEMENT ACT 1995

FISHERIES (BIOSECURITY) ORDER 2022

Pursuant to the powers under section 270 of the *Living Marine Resources Management Act 1995* ("the Act") that were delegated to the Director (Marine Resources) (position number 702830) on 12 November 2018 by the Minister acting pursuant to section 20(1) of the Act I make the following order:

1. Short title

This order may be cited as the *Fisheries (Biosecurity) Order 2022*.

2. Specification

This order is made –

- (a) in respect of the harmful disease abalone *viral ganglioneuritis*; and
- (b) to implement treatment and testing requirements designed to prevent the introduction of that disease into State waters.

3. Directions issued

- (1) That an abalone processor must, unless otherwise authorised, ensure that no abalone live-holding water is discharged into State waters from any holding premises used under the relevant licence unless that water has-
 - a) been treated using a system capable of achieving, on comparing water immediately prior to entering treatment with water immediately on leaving treatment, a minimum 3 log 10 reduction in total marine heterotrophic bacteria; and
 - b) achieved a discharge concentration value of <3 log 10 (≤ 999 bacterial colony forming units per mL).
- (2) That an abalone processor must, in each of the testing periods-
 - a) cause a water sample to be taken by an agent of an approved service from each holding premises used under the relevant licence; and
 - b) cause the water sample to be tested by an approved laboratory for the discharge concentration value referred to in subclause (1)(b); and

- c) submit the results of that testing to the Secretary.
- (3) That an abalone processor must allow access to any holding premises used under the relevant licence to any officer of the Department of Natural Resources and Environment Tasmania for the purposes of-
 - a) inspecting the abalone live-holding water treatment system;
 - b) inspecting any abalone held on the premises;
 - c) seizing any suspected diseased abalone for testing; and
 - d) taking a water sample for testing for the discharge concentration value referred to in subclause (1)(b).

4. Interpretation

In this order –

"abalone" means live fish of the genus *Haliotis*;

"abalone processor" means the holder of a fish processing licence that authorises the processing of abalone;

"approved laboratory" means a laboratory approved to conduct tests relevant to ascertaining performance related to the standards in subclauses 3(1)(a) and 3(1)(b);

"approved service" means a service approved to take samples to be provided for testing by an approved laboratory;

"Tasmania's biosecurity regions" means the regions specified in Part 1 and described in Part 2 of the Schedule to this order;

"holding premises" means premises used to hold abalone taken from outside the relevant biosecurity region for those premises;

"introduction" includes re-introduction;

"relevant biosecurity region", for premises, means, with reference to Tasmania's biosecurity regions, the biosecurity region adjacent to that part of the State's coastline where, or closest to where, those premises are situated;

"relevant licence", for an abalone processor, means the fish processing licence that authorises the abalone processor to process abalone;

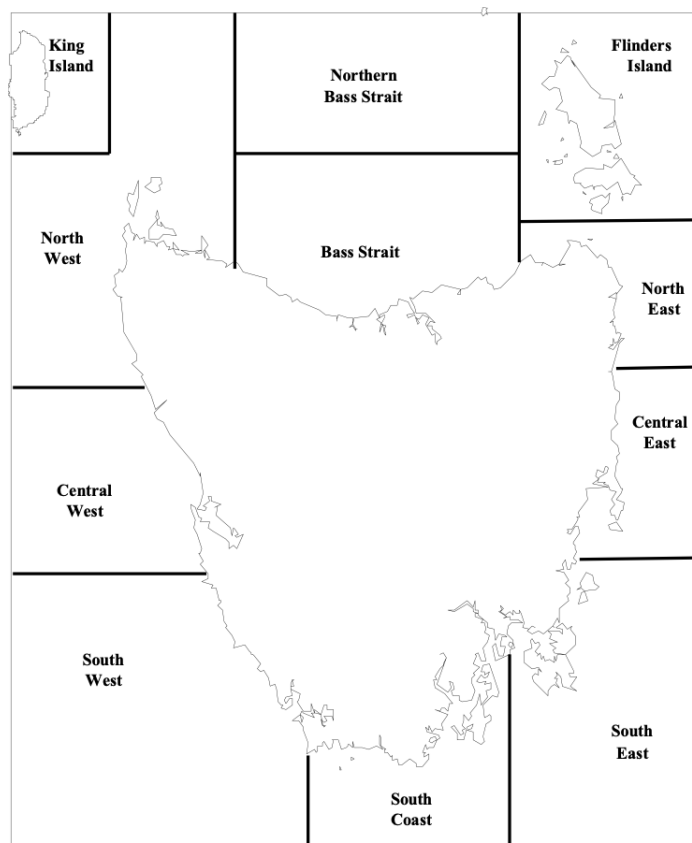
"testing periods" means the following periods:

- a) October of each calendar year;
- b) the four week period commencing six weeks before each Chinese New Year.

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *State Service (Restructuring) Order 2022*

This order amalgamates with the Department of Natural Resources and Environment Tasmania each of the following parts of the Department of State Growth:

- (a) the part that is primarily responsible for forest policy;
- (b) the part known as the Forest Practices Authority;
- (c) the part known as Private Forests Tasmania.

(2) *Administrative Arrangements Order (No. 2) 2022*

This order –

- (a) assigns to Ministers of the Crown the administration of Government departments, parts of departments and State authorities and Acts, or parts of Acts or subject matter of Acts, and other instruments of a legislative character; and
- (b) specifies which Government department, part of department or State authority is responsible to a Minister in relation to the administration of those Acts or parts of Acts or that subject matter and other instruments; and
- (c) revokes the *Administrative Arrangements Order 2022*.

(3) Proclamation under section 2 of the *Public Sector Superannuation Reform Amendment Act 2019*

This proclamation fixes 31 March 2022 as the day on which that Act commences.

(4) *Public Sector Superannuation Reform Amendment Regulations 2022*

These regulations amend the *Public Sector Superannuation Reform Regulations 2017* by –

- (a) providing for interim pensions to be paid to certain surviving partners; and
- (b) allowing for determination of terminal medical conditions and payment of benefits in relation to such determinations; and
- (c) allowing for reduction or suspension of invalidity pensions in certain cases; and
- (d) allowing for certain deductions from pensions for costs incurred in paying pensions; and
- (e) inserting provisions, in relation to certain ambulance officers and employees of the Tasmania Fire Service, modelled on the provisions of trust deeds in relation to superannuation for such officers and employees.

- b) have a medical exemption, that applies to the vaccinations for the disease, that has been recorded on the Australian Immunisation Register, operated by or on behalf of the Commonwealth Government.

2. Exceptional circumstances

Demonstrated to the satisfaction of the Head of Agency.

- Qualifications as established by the Tasmanian Industrial Commission in the Teaching Service (Tasmanian Public Sector) Award, 2005.
- Current certificate of registration; or provisional registration; or limited authority to teach granted by the Teachers Registration Board (Tasmania) in accordance with the provisions of the *Teachers Registration Act 2000*. Please note that a person with a limited authority to teach can only be employed on a fixed-term basis.

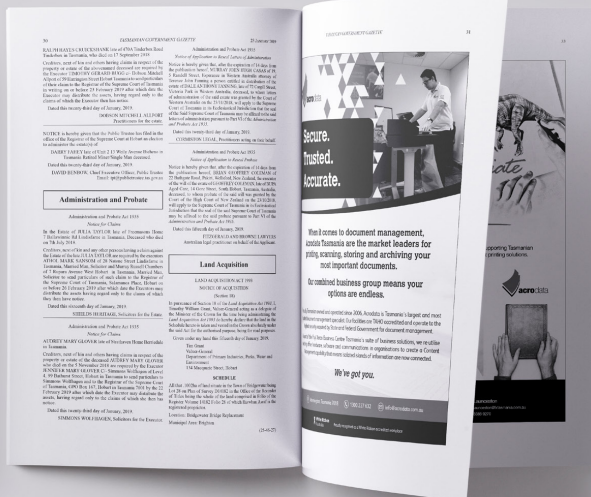
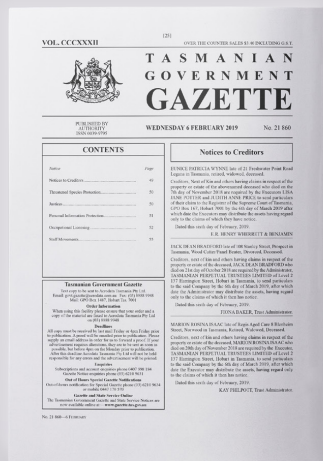
