#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Road Amendment Rules (No. 2) 2022*

These rules amend rule 79A of the *Road Rules* by clarifying which classes of vehicles, and which workers, drivers must give way to in certain circumstances.

(2) *Traffic (Compliance and Enforcement) Amendment Regulations 2022*

These regulations amend the *Traffic (Compliance and Enforcement) Regulations 2017* by inserting new traffic infringement notice offences relating to new rules in the *Road Rules* that relate to slowing down around certain vehicles and persons.

(3) *Vehicle and Traffic (Driver Licensing and Vehicle Registration) Amendment Regulations 2022*

These regulations amend the *Vehicle and Traffic (Driver Licensing and Vehicle Registration) Regulations 2021* by inserting new demerit point offences relating to certain circumstances where a driver must slow down and give way to other vehicles and persons.

(4) *Poisons Amendment Regulations 2022*

These regulations amend the *Poisons Regulations 2018* by permitting –

- (a) The continued dispensing of restricted substances without prescription in specified circumstances; and
- (b) The storage of narcotic substances or prohibited substances, with substances, or a package that contains substances, that are intended to be supplied under a VAD substance prescription under the *End-of-Life Choices (Voluntary Assisted Dying) Act 2021*.

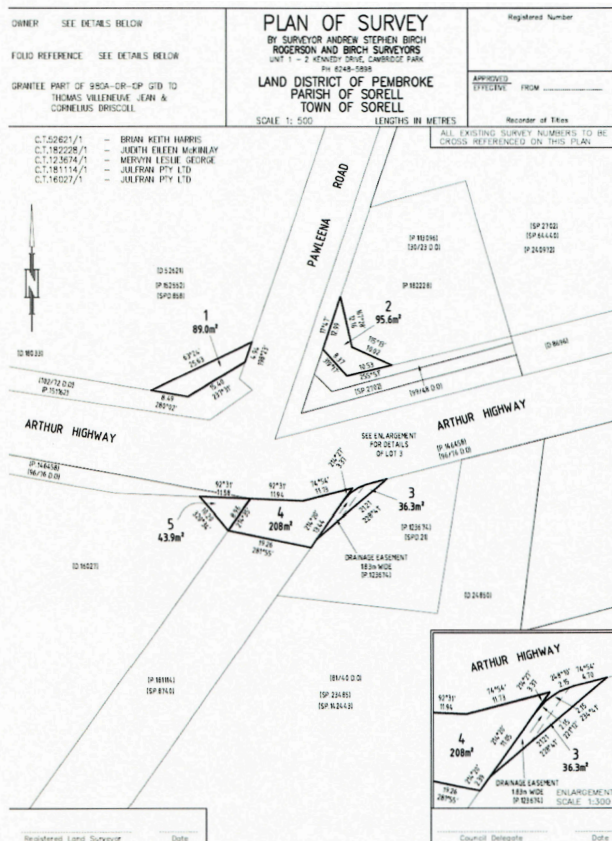

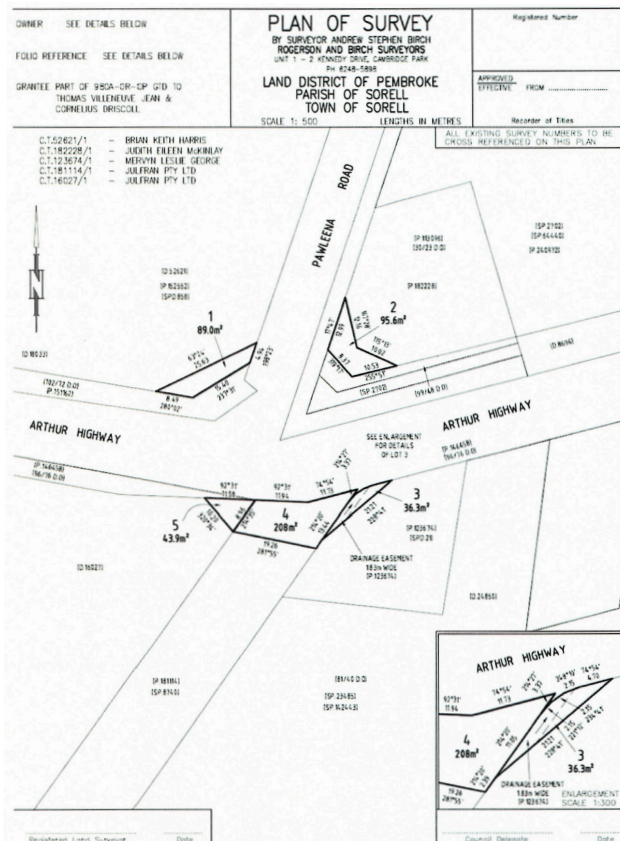

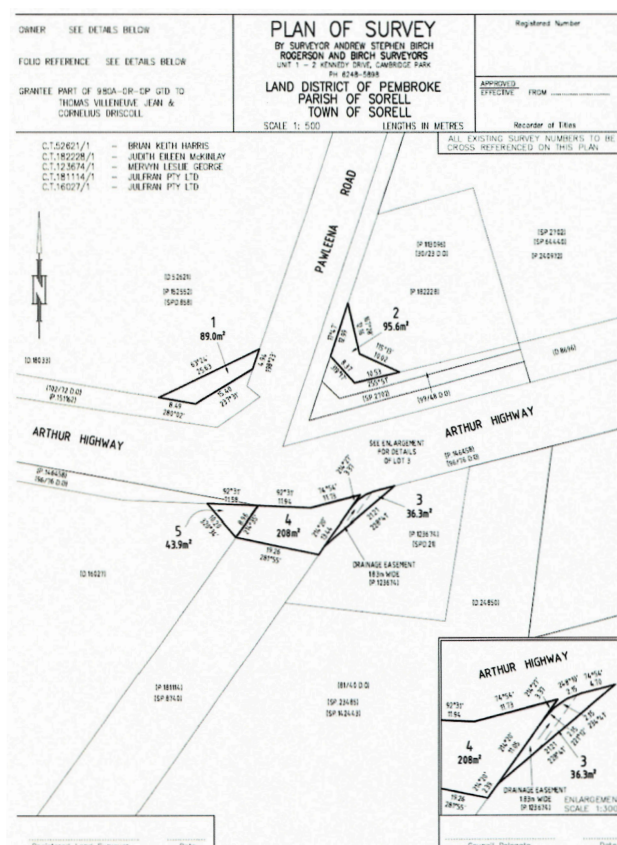

**Essential Requirements:** As a result of a risk assessment process the Head of Agency gave consideration to where vaccination is a necessary control to protect the health and safety of workers and the community and therefore it has been determined that prior to appointment to these duties a person is to provide evidence that they are vaccinated against the disease known as COVID-19.

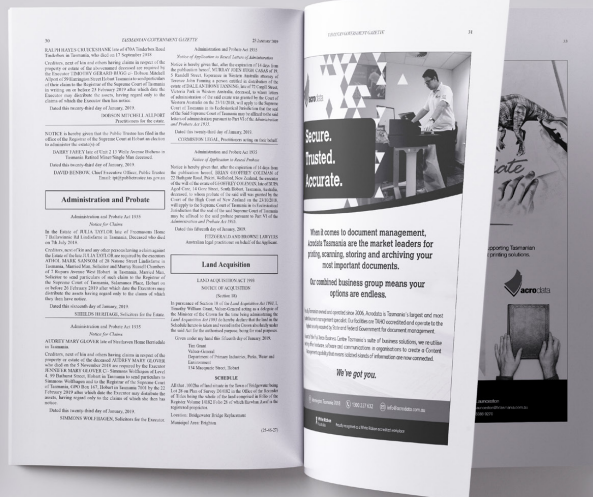
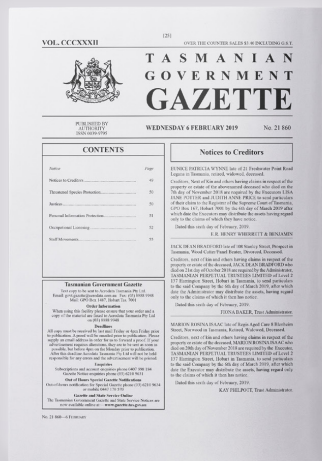
**Desirable Requirements:** Tertiary qualification(s) in particular human resources information systems or equivalent.

State Service employees aggrieved by this intention may make application to the Tasmanian Industrial Commission for a review under section 50(1)(b) of the *State Service Act 2000*. Applications for review are to be lodged with the Tasmanian Industrial Commission within 14 days of the publication of this notice in the Tasmanian Government Gazette.

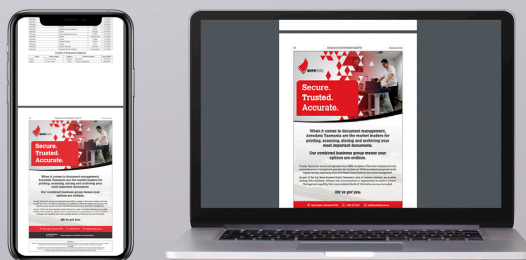
