# **Fee Units**

#### FEE UNITS ACT 1997

The Fee Units Act 1997 (the Act) provides for automatic changes in Government fees and charges in accordance with movements in the Hobart Consumer Price Index (CPI). The Act also provides for adjustments to be made on the basis of factors other than movements in the CPI through a fee unit adjustment factor.

In accordance with section 7 of the Act, I give notice that:

- the value of a fee unit for the financial year commencing 1 July 2023 is \$1.78; and
- the adjustment factor used in the calculation of the fee unit is 0.02632.

In determining the adjustment factor for the purpose of section 5(4) of the Act, I have taken into consideration the impact on CPI of specific events that occurred in 2022. In response, I have determined an adjustment factor of 0.02632 for the calculation of a fee unit under the Act for 2023-24.

The amount of the adjustment factor ensures that the fee increase for 2023-24 reflects the underlying growth in inflation for the period (as measured by change in the weighted median of national CPI between 2021 and 2022). This will result in fees increasing by 4.71 per cent in 2023-24.
