GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Duties (Concession Extension) Order 2023

This order amends the *Duties Act 2001* by extending the eligible periods that apply in respect of a duties concession for specified first home buyers, or specified pensioners buying property, in certain circumstances.

(2) Land Tax (Exemption Extension) Order 2023

This order amends the Land Tax Act 2000 by extending the eligible periods that apply in respect of a land tax exemption for certain newly constructed properties, or former short-stay accommodation premises, in certain circumstances.


