Work Health and Safety

WORK HEALTH AND SAFETY ACT 2012

Variation of the Forest Safety Code (Tasmania) 2007

I hereby give notice pursuant to section 274(4) of the Work Health and Safety Act 2012 (the WHS Act), that:

- I have varied the Forest Safety Code (Tasmania) 2007, which, in accordance with the Work Health and Safety (Transitional and Consequential Provisions) Act 2012 and regulation 60 of the Work Health and Safety (Transitional) Regulations 2012, is an approved code of practice for the purposes of the WHS Act.
- The variation takes effect in Tasmania on and from the date this Notice is published in the Gazette.
- The abovementioned code of practice, as varied and dated November 2021, is to be known as the Forest Safety Code (Tasmania) 2021.

The Forest Safety Code (Tasmania) 2021 (the Code) provides practical guidance and applies to persons who have responsibilities under the WHS Act and *Work Health and Safety Regulations* 2012 (the WHS Regulations) in forestry operations in Tasmania.

The variations are summarised as follows:

- The date of the Code has been updated to November 2021 for version control.
- The introduction has been revised to include reference to the review process; discussion of the structure and approach of the Code, and how to use the Code. It provides brief information on other relevant legislation, including the *Forest Practice Act 1985*, the Forest Practices Code and the Heavy Vehicle National Law.
- Outdated legislative references have been removed and the text has been updated to align with the relevant requirements of the WHS Act and the WHS Regulations, and relevant approved codes of practice. In particular, responsibilities for the various duty holders under the WHS Act are set out, with practical references to how they relate to landowners, forest managers or landowners who engage contractors, forest contractors, and farm forestry.
- Consistent with the WHS Act and WHS Regulations, the discussion of risk management, including hazard identification, risk assessment and risk controls has been updated, and strengthened.
- Information on the legislative requirements to consult, cooperate and coordinate on work health and safety matters has been consolidated, expanded, and updated in line with the current legislation.
- Terminology and language has been aligned with that in the legislation.

- Editorial improvements have been made to organise the information in a logical structure, improve clarity and better reflect modern codes of practice.
- Reference is made to national guidance material, where appropriate.
- Technical information has been updated in line with contemporary practices and equipment.
- · New sections or information has been added on:
 - steep slope harvesting with winch-assist machines;
 - in-field processing including in-field chipping, portable sawmilling, and product processing;
 - shovel logging; and
 - silviculture operations in plantations including tree planting, weed control, use of tractors and all-terrain vehicles, crop protection, use of unmanned aerial vehicles (drones) and working under helicopters.
- Requirements for the haulage, loading and unloading of logs have been updated with references and omissions to take into account that the Heavy Vehicle National Law addresses the safety of log transport after it leaves the forest. Specific omissions are the provisions relating to load release and unloading (non-sawmill sites), securing jinkers or trailers and loading/unloading of rail wagons.
- Provisions specific to quarries have been omitted, given that quarries are covered by the Mines Work Health and Safety (Supplementary Requirements) Act 2012.

EMERGENCY MANAGEMENT ACT 2006 DIRECTIONS IN RELATION TO PERSONS ARRIVING IN TASMANIA

Preamble

A significant threat of an emergency is occurring in Tasmania due to the coronavirus disease COVID-19 ('the Disease'). To protect persons from distress, injury or death, I make the following directions in the exercise of emergency powers authorised under Section 40 of the *Emergency Management Act 2006* and pursuant to clause l(l)(b) of Schedule 1 to that Act.

Commencement and Revocation

- 1) These directions take effect from 12:01am on 26 February 2022 and will continue in force until further notice.
- (2) The *Directions in relation to persons arriving in Tasmania* made by me on 18 January 2022 are revoked with effect from 12:01am on 26 February 2022.

Cruise Ships

(3) A person, other than a crew member or person approved by the Deputy State Controller, is prohibited from entering Tasmania on a cruise ship.

Release from Quarantine

(4) A person who is in quarantine pursuant to a Direction contained within the *Directions in relation to persons* arriving in Tasmania made on 18 January 2022, is no longer subject to such requirement.
