Defined terms

1. "Access Easement" means the following rights for the Dominant Owner:

 - (b) the full and free right to go, pass and repass at all times and for all purposes with or without vehicles over the Access Easement Land for the purposes of the Irrigation

- District;
- (c) for the purposes of the rights conferred under paragraphs (a) and (b), the full and free right and liberty for the Dominant Owner at all times to:
 - (i) construct a road on the Access Easement Land to the specification determined by the Dominant Owner in its absolute and unfettered discretion; and
 - (ii) to replace, relocate, remove, operate, modify, maintain, enhance, inspect and repair that road;
 - (d) the full and free right and liberty for the Dominant Owner at all times to enter on and remain on and go over the Access Easement Land for the purpose of exercising any of the other rights conferred by the Access Easement; and
 - (e) the full and free right and liberty for the Dominant Owner at all times to take on to or remove from or over the Access Easement Land anything which the Dominant Owner considers reasonably necessary or desirable to exercise the other rights conferred by the Access Easement including, without limitation, any plant, machines, vehicles, equipment or materials.
2. "The Dominant Owner" means Tasmanian Irrigation Pty Ltd ACN 133 148 384 and any other owner for the time being of any part of Lot 2 on Plan of Survey P180145 and Lots 4 and 5 on Plan of Survey P180146.

GENERAL AUTHORITY IMPORT OF DOMESTIC DOGS

ANIMAL HEALTH ACT 1995

Section 18

1. I, Kevin de Witte, being and as the Chief Veterinary Officer under the *Animal Health Act 1995* (the Act), and acting under section 18 of the Act, hereby –
 - (a) revoke the general authority issued under section 18 of the Act by the Chief Veterinary Officer for the importation of dogs dated 1 August 1997; and
 - (b) issue a general authority for the importation of domestic dogs, subject to the conditions in clause 2 below.
2. A dog must not be imported into Tasmania unless the dog is visually healthy, free of any ticks, or signs or symptoms of tick infestation, and complies with at least one of the following paragraphs:

- (a) the dog has been treated with praziquantel at a dose rate of 5 mg/kg body weight within 14 days before entry to Tasmania, and is accompanied by the following proof of treatment:
 - (i) a statement that the dog has been treated in accordance with this condition, made in writing by a veterinarian registered in the exporting state or territory; or
 - (ii) a declaration signed by the owner or person in charge of the dog that it has been treated in the exporting state or territory in accordance with this condition; or
 - (iii) other documentary evidence to enable an authorised officer to verify that it has been treated in accordance with this condition, such as the pill packet; or
 - (b) the dog is returning to Tasmania after not more than 14 days in another state or territory and is accompanied by the following proof of movement –
 - (i) a statement obtained before leaving Tasmania from the Tasmanian Canine Association, the Department of Primary Industries, Parks, Water and Environment, or the Office of Racing Integrity, that identifies the dog and contains the expected date of departure; or
 - (ii) a statutory declaration made by the owner or consignor of the dog certifying compliance with this condition; or
 - (iii) shipping documents that describe the dog adequately and can enable an authorised officer to verify compliance with this condition; or
 - (c) the dog is –
 - (i) an assistance dog or guide dog; or
 - (ii) a greyhound that will be racing in Tasmania within six days of importation, providing this is confirmed by documentation from the Office of Racing Integrity; or
 - (iii) a puppy under the age of 12 weeks; or
 - (iv) a law enforcement dog.
3. This authority takes effect on the date of its publication in the Gazette and remains in force until the repeal of the Act, unless sooner revoked.

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Evidence (Children and Special Witnesses) Regulations 2021*

These regulations prescribe the Tasmania Law Reform Institute as a law reform body for the purposes of section 7D of the *Evidence (Children and Special Witnesses) Act 2001*.

(2) *Poisons Amendment Regulations (No. 2) 2021*

These regulations amend the *Poisons Regulations 2018* by removing the requirement for the Secretary to authorise the prescription, sale or supply of cannabidiol.

(3) *Health (Fees) Amendment Regulations 2021*

These regulations amend the *Health (Fees) Regulations 2017* by increasing certain fees that may be charged in respect of non-nursing-home-type patients.

(4) Proclamation under section 2 of the *Justice Miscellaneous (Court Backlog and Related Matters) Act 2020*

This proclamation fixes 1 July 2021 as the day on which the *Justice Miscellaneous (Court Backlog and Related Matters) Act 2020* commences.

(5) Proclamation under section 4(2) of the *Tasmanian Civil and Administrative Tribunal Act 2020*

This proclamation fixes 1 November 2021 as the establishment day for the purposes of the *Tasmanian Civil and Administrative Tribunal Act 2020*.

(6) *Workers Rehabilitation and Compensation Regulations 2021*

These regulations –

- (a) make provision in relation to certain practices and procedures of the Workers Rehabilitation and Compensation Tribunal, the payment of costs and miscellaneous other matters required to be prescribed for the purposes of the *Workers Rehabilitation and Compensation Act 1988*; and
- (b) are made consequentially on the repeal of the *Workers Rehabilitation and Compensation Regulations 2011* under section 11 of the *Subordinate Legislation Act 1992*.

(7) *Electricity Supply Industry Concession Amendment (Winter Energy Supplement) Order 2021*

This order amends the *Electricity Supply Industry Concession Order 2016* by –

- (a) providing for an additional concession of \$125 to be available to persons who are eligible annual electricity concession holders on a day between 30 June 2021 and 1 September 2021 (both inclusive); and
- (b) requiring medical certificates, in relation to persons who are eligible for the life support concession or the medical cooling or heating concession, to only be provided every 4 years, rather than every 2 years.

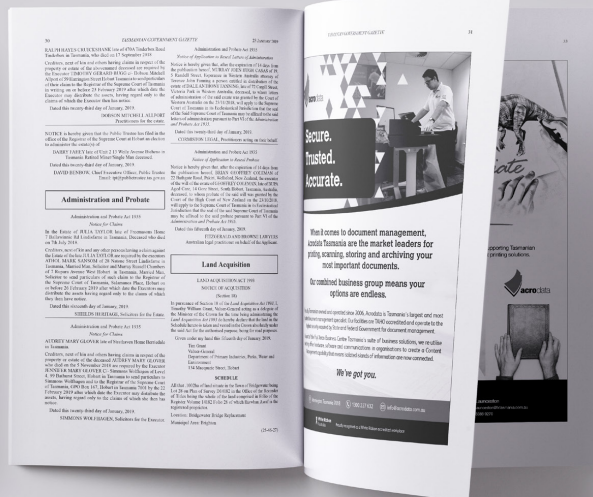
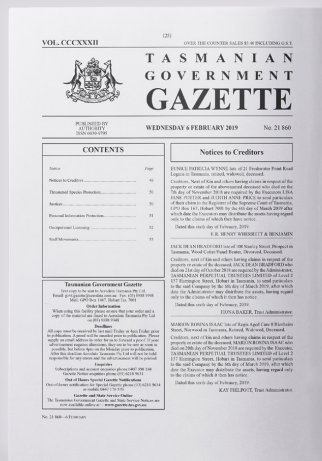

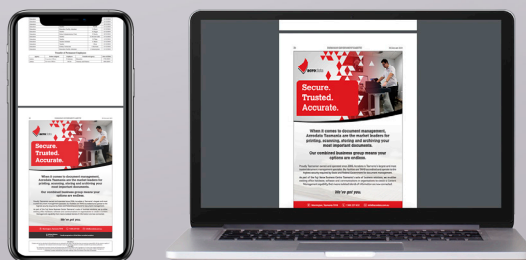
