#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

- Proclamation under section 2 of the *Treasury Miscellaneous (Cost of Living and Affordable Housing Support) Act 2021* This proclamation fixes 1 September 2021 as the day on which amendments to the *Duties Act 2001*, relating to the duty payable
   on MAIB certificates of premium, commence.
- (2) Vehicle and Traffic (Driver Licensing and Vehicle Registration) Amendment Regulations (No. 3) 2021

These regulations amend the Vehicle and Traffic (Driver Licensing and Vehicle Registration) Regulations 2021 by specifying -

- a) the method of calculating the fire levy component of certain motor vehicle registration payments if a registration period is other than 12 months; and
- b) the administrative fee payable in relation to certain motor vehicle registration payments if a registration period is other than 12 months.
- (3) Emergency Management Amendment Regulations 2021

These regulations amend the Emergency Management Regulations 2020 by -

- a) enabling an infringement notice to be issued in respect of the offence of providing false or misleading information to an emergency management worker; and
- b) increasing the penalty that may be payable by an individual in respect of an infringement notice under the *Emergency* Management Act 2006.
