Personal Information Protection

PERSONAL INFORMATION PROTECTION ACT 2004 EXEMPTION UNDER SECTION 14

I, Guy Barnett MP, Minister for Justice, being and as the Minister responsible for the administration of the *Personal Information Protection Act 2004* ("the Act"), upon being satisfied that the public benefit in doing so outweighs to a substantial degree the public benefit from compliance with the Personal Information Protection Principles, hereby approve an application dated 25 June 2024 made under section 13 of the Act by the Department of Premier and Cabinet for an exemption from compliance with the Act, subject to the following conditions:

1. That any information that would be protected by the Act can be disclosed to Mr Sam Tatarka OAM, or any person assisting Mr Tatarka, for the purpose of conducting an independent review in relation to legal assistance met by the Crown provided to current and former public officers in respect of the *Commission of Inquiry into the Tasmanian Government's Responses to Child Sexual Abuse in Institutional Settings*; That information can only be shared whereby such information is, or has the potential to be relevant to the independent review; That if information is shared pursuant to this exemption that is not relevant and is not potentially relevant to the independent review, it will be returned to the Department of Premier and Cabinet and in compliance with the *Archives Act 1983*.

Details of the Application

The Department of Premier and Cabinet has applied under Section 13 of the *Personal Information Protection Act 2004* ("the Act") for an exemption under Section 14 of the Act to allow for information within its custody and control to be disclosed and used by Mr Sam Tatarka OAM for the purpose of conducting an independent review of whether there are appropriate grounds to require any Public Officers, who received a grant of legal assistance pursuant to Employment Direction No. 16 *Indemnity and Legal Assistance*, or whose legal fees were otherwise paid by the Crown, in the course of the *Commission of Inquiry into the Tasmanian Government's Responses to Child Sexual Abuse in Institutional Settings* to reimburse the Crown for reasonable costs and expenses.

The exemption is to ensure that all information relevant to independent review can be obtained by the independent reviewer, and utilised within the constraints of the law, whilst still protecting the privacy of individuals.


