

1. The portion of the Wilmot Road reserve shown on Certificate of Title 214370/1 shown marked pink on the attached site plan marked 50117 DS 01 "**BCC1**" (the Land).

2. Folio 214370-1 shows Alexander Shekleton as the owner of the Land.

- a. The title land originates from Folio 15-59 in the name of Alexander Shekleton dated 1873 which had its last dealing recorded in 1891. The Recorder of Titles subsequently converted the balance of land into loose leaf title Folio 2544-19 and subsequently automated the title into computer Folio 214370-1.
- b. Will No 4986\*\*\* recites that Alexander Shekleton died at South Brunswick in Victoria on 19 July 1896 and that the Supreme Court of Tasmania granted probate on or about 2 October 1896 to Martha Ann Shekleton and Edmund Cooper being the remaining executrix and executor named in the will.
- c. Will No 4310\*\*\* dated 4 January 1957 recites that the Public Trustee elected to become the administrator of the intestate estate of the late Martha Ann Shekleton who had died in Launceston on or about 9 October 1911.
- d. Edmund Cooper (a farmer from Table Cape and later from King Island) died. He married Clara Shekleton as a 24 year old in 1897. He was recited as a party to a dealing in Folio 253-96 in 1920 and Folio 292-6 in 1921. There is no Tasmanian Names Index will/probate entry for an Edmund Cooper around this timeline.
- 3. Current ownership of Folio 214370-1
  - a. The line of representation appears to have been broken.
  - b. The owner of the land is the (unknown) estate of the late Edmund Cooper being the surviving personal representative of the estate of the late Alexander Shekleton who died on or about 2 October 1896.

(1) Burial and Cremation Amendment Regulations 2024

These regulations amend the *Burial and Cremation Regulations 2015* by adding alkaline hydrolysis as a prescribed means of cremation.

- (2) Public Health (Smoke-free Areas) Regulations 2024
  - These regulations -
    - (a) for the purposes of the Public Health Act 1997, declare certain pedestrian malls and bus malls to be smoke-free; and
    - (b) are made consequentially on the repeal of the *Public Health (Smoke-free Areas) Regulations 2014* under section 11 of the *Subordinate Legislation Act 1992*.
- (3) Reproductive Health (Access to Terminations) Regulations 2024
  - These regulations
    - (a) prescribe
      - (i) health services for the purposes of section 7 of the Reproductive Health (Access to Terminations) Act 2013; and
      - (ii) an offence against a provision of the *Reproductive Health (Access to Terminations) Act 2013* as an infringement offence for which an infringement notice may be issued and served; and
      - (iii) the penalty payable under that infringement offence; and
    - (b) are made consequentially on the repeal of the *Reproductive Health (Access to Terminations) Regulations 2014* under section 11 of the *Subordinate Legislation Act 1992*.
