NOTICE FOR THE TASMANIAN SCALLOP FISHERY COMPRISING ACTIVITIES BY WAY OF FISHING FOR COMMERCIAL PURPOSES -

I, Dr Ian Dutton, General Manager - Marine Resources, Department of Natural Resources and Environment, acting pursuant to a delegation from the Minister for Primary Industries and Water and acting pursuant to Section 20(1) of the *Living Marine Resources Management Act 1995* (the Act), in accordance with the *Fisheries (Scallop) Rules 2020*, hereby:

1. Determine under Rule 18(1)(a), the dates of the open season for the commercial scallop fishery, for the area of State waters as determined below are from 12:01am 7 July 2023 to 11:59pm 31 December 2023 (inclusive).
2. Determine that the minimum size limit for commercial scallops (*Pecten fumatus*) that can be taken by the commercial fishery for the area of State waters as determined below, is 85mm at its widest part
3. Determine under Rule 19(1)(a) and 19(1)(b), the specified area of State waters to be open to the commercial scallop fishery for commercial scallop dredging are State waters adjacent to the north west coast of Tasmania west of a line of longitude at 146° 31.55' East running due north from Point Sorell, and north of the line of latitude at 41° South running due west of Bluff Hill Point on the west coast, excluding: State waters contained within the following boundary:
 - i. latitude 40° 19.2' S, longitude 144° 54.3'E; to
 - ii. latitude 40° 19.2' S, longitude 145° 04.8'E; to
 - iii. latitude 40° 21.' S, longitude 145° 04.8' E; to
 - iv. latitude 40° 21' S, longitude 145° 54.3'E; to
 - v. latitude 40° 19.2' S, longitude 144° 54.3'E.

LAUNCESTON CITY COUNCIL**ON-STREET PARKING PENALTIES BY-LAW
NO. 1 of 2023**

A by-law made under sections 145 and 161 of the *Local Government Act 1993* for the purpose of prescribing penalties for infringement notices pursuant to section 100 of the *Local Government (Highways) Act 1982*.

PART 1 – PRELIMINARY**1. Short title**

This by-law may be cited as the *On-Street Parking Penalties By-Law No. 1 of 2023*.

2. Repeal

Part 7 of the *Launceston City Council Parking By-Law No. 2 of 2013* is repealed.

3. Interpretation

In this by-law, unless the contrary intention appears:

"penalty unit" means a sum prescribed under the provisions of the *Penalty Units and Other Penalties Act 1987*;

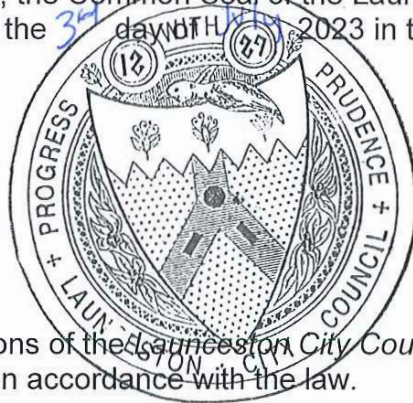
4. Prescribed penalties for parking offences under the *Local Government (Highways) Act 1982*

For the purposes of section 100(4) of the *Local Government (Highways) Act 1982*, the prescribed penalty for an infringement notice issued for an offence under section 97, 98 or 99 of that Act is the applicable amount specified adjacent to the offence in the following table:
