FOR THE 2024-25 QUOTA PERIOD**

- C. The specified manner in which an approved VMS unit is to be used is that it is required to be operating at all times.

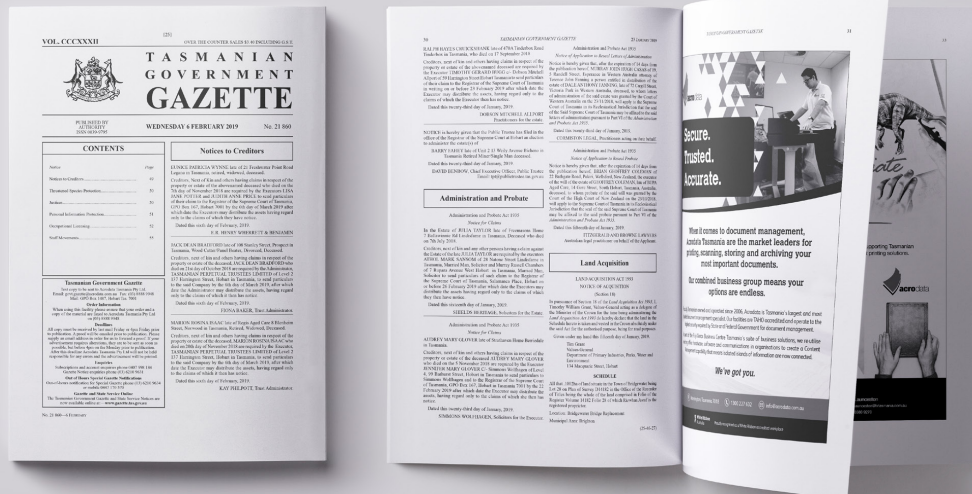
