APPROVAL OF AMENDMENTS OF THE OCCUPATIONAL LICENSING (BUILDING SERVICES WORK) DETERMINATION

Notice is hereby given that in accordance with sections 30 and 31 of the *Occupational Licensing Act 2005*, amendments of the OCCUPATIONAL LICENSING (BUILDING SERVICES WORK) DETERMINATION, have been approved as version 2.3, commencing on 1 October 2024.

This Determination establishes requirements for:

- Licensing of building services providers;
- Owner builder permits and authorisation of owner builder training providers;
- Insurance of building services providers and owner builders; and
- Conduct of building services providers through Codes of Practice.

The amendments in v.2.3 provide for:

- Permit Authority entity licensing details to be added;
- Updating of references to the indemnity of state servants performing building services work; and
- Deletion of outdated transitional provisions.



Gaming Control

Gaming Control Act 1993 Ministerial Direction

To: Tasmanian Liquor and Gaming Commission

I give you the following Direction under section 127 of the *Gaming Control Act 1993*.

11 September 2024

MINISTER FOR FINANCE

Title

This Direction may be cited as the *Tasmanian Liquor and Gaming Commission Ministerial Direction (No.3) 2024*.

Commencement

This Direction takes effect on the date of Gazetteal.

Direction

The Tasmanian Liquor and Gaming Commission is to:

1. Determine the most appropriate manner by which to increase the frequency that Responsible Conduct of Gambling training is required to be undertaken from every five years to every two years.
2. Implement the requirement for more frequent training through amendment to the Commission's Responsible Gambling Code of Practice and any other relevant regulatory instrument.

In implementing this direction the Commission should:

- a) consider:
 - i. how more frequent training is to be provided;
 - ii. the cost to employees of the additional training;
 - iii. the ability of registered training organisations to deliver additional courses; and
- b) consult with the hospitality industry in those considerations.

The increase in the frequency of training should occur as soon as practicable.
