LIVING MARINE RESOURCES MANAGEMENT ACT 1995 FISHERIES (SCALEFISH) RULES 2015

NOTICE OF THE DATES OF THE CLOSED SEASON FOR PART OF THE SCALEFISH FISHERY AND NOTICE OF SCALEFISH FISHERY CLOSURE TO SPECIFIC ACTIVITIES

I, John Adams, Acting General Manager (Marine Resources) in the Department of Natural Resources and Environment Tasmania, acting pursuant to a delegation from the Minister for Primary Industries and Water hereby determine under rule 11(1) of the *Fisheries (Scalefish) Rules 2015* (the Rules):

- A. that the dates of the closed season for that part of the Scalefish Fishery specified in schedule 1 are from 12:01 am 21 August 2023 to 11:59 pm 31 October 2023; and
- B. that the parts of the scalefish fishery specified in schedule 1 are closed to, or in respect of, the activities specified in schedule 2.

SCHEDULE 1

All that part of the Scalefish Fishery in State waters adjacent to the north coast of Tasmania and in Bass Strait:

- (a) bounded in the west by an imaginary line starting at Cape Grim and then running due west along the line of latitude at 40°40'S to the limit of State waters; and
- (b) bounded in the north by the limit of State waters; and
- (c) bounded in the east by an imaginary line starting at Cape Naturaliste and then running due east along the line of latitude at 40°50'S to the limit of State waters.

SCHEDULE 2

- 1) The take of all squid species, including southern calamari (Sepioteuthis australis).
- 2) The possession of squid other than the:
 - (a) possession of Gould's squid by the holder of a Commonwealth authority that were taken under that Commonwealth authority, or by the holder of a Tasmanian fishing licence (automatic squid jig) that were taken under the authority of that licence in State waters;
 - (b) possession of squid (whole or part) where the person possessing the squid can establish that the squid was purchased from a commercial supplier or was taken by the holder of a fishing licence (personal) in an open season and open area.
- 3) The possession of squid jigs attached to a hand line or rod and line.
- 4) Transiting the closed area specified in schedule 1 whilst in possession of squid species taken outside of the closed area, other than that specified in clause 2) of this schedule.

The squid fishery (including southern calamari and Gould's squid) will be subject to a spawning closure from Monday, 21 August 2023 to Tuesday, 31 October 2023 (inclusive).

The closure applies to both non-commercial and commercial fishers.

This closure is to safeguard the fishery and protect adult calamari when they are most vulnerable. The closure applies to all squid species for the purpose of effective compliance.

It is prohibited to take squid (including calamari and Gould's squid) in this area during the closure. In addition, a person cannot possess squid for use as bait unless they can prove that the squid being used for bait were purchased from a commercial supplier or was taken by a commercial fisher in an open season and open area.

Squid jigs are not permitted to be attached to a line (hand line or rod and line) when in the closed area.

Transiting the closed area in possession of squid taken outside the area is not permitted—with some exceptions as detailed in part 2(b) of the notice.

LIVING MARINE RESOURCES MANAGEMENT ACT 1995 PUBLISHED NOTICE - DATES OF CLOSING OF THE COMMERCIAL ROCK LOBSTER FISHERY – NORTH EAST CATCH CAP AREA RULE 10 OF THE FISHERIES (ROCK LOBSTER) RULES 2022

I, John Adams, Acting General Manager – Marine Resources in the Department of Natural Resources and Environment Tasmania, acting pursuant to a delegation from the Minister for Primary Industries and Water, hereby determine under rule 10 of the *Fisheries (Rock Lobster) Rules 2022* (the Rules) that:

- 1) the part of the commercial rock lobster fishery that comprises of the activities of the taking of rock lobster for commercial purposes in "north eastern waters" is closed from 00:01 10 August 2023 to midnight 29 February 2024 inclusive; and
- 2) the setting of a rock lobster pot for commercial purposes in, "north eastern waters" is closed from 00:01 10 August 2023 to 13:00 29 February 2024 inclusive;

Where:

"north eastern waters" is defined to mean the area of State waters adjacent to the north east coasts of Tasmania, east of the line of longitude 146° 32' 00" East (Point Sorell) on the north coast, and north of the line of latitude 40° 59' 35" South (Eddystone Point) on the east coast.

Words and expressions used in this public notice have the same meaning as in the Living Marine Resources Management Act 1995 and the Fisheries (Rock Lobster) Rules 2022.
