LIVING MARINE RESOURCES MANAGEMENT ACT 1995

Section 270

FISHERIES (BIOSECURITY) ORDER (No. 5) 2008

I MAKE the following Order under section 270 of the *Living Marine Resources Management Act 1995* issuing directions aimed at controlling a harmful disease.

Short title

1. This Order may be cited as the *Fisheries (Biosecurity) Order (No. 5) 2008*.

Specification

2. This Order is made in respect of the disease *Abalone Viral Ganglioneuritis* and is aimed at preventing the potential spread or amplification of that disease through the activities of collecting broodstock and holding broodstock in a marine farm facility.

Directions Issued

3. That, the holder of a marine farming licence endorsed to farm abalone receiving or holding abalone harvested from the wild to be used for the purposes of broodstock must comply with a Abalone Broodstock Biosecurity Protocol approved by the Chief Veterinary Officer of Tasmania appointed under the *Animal Health Act 1995* or his delegate.

Interpretation

4. All expressions used in this Order have the same meaning as in the *Living Marine Resources Management Act 1995* and applicable subordinate legislation unless the context implies a different meaning.

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Boundary Fences Regulations 2008*

These regulations—

- (a) prescribe forms for the purposes of section 9 of the *Boundary Fences Act 1908*; and
- (b) are made consequentially on the repeal of the *Boundary Fences Regulations 1998* under section 11 of the *Subordinate Legislation Act 1992*.

(2) *Electricity Supply Industry Regulations 2008*

These regulations—

- (a) prescribe —
 - (i) the circumstances in which licences authorising the generation of electricity are not required; and
 - (ii) the information that holders of certain licences are required to publish and how that information is to be published; and
 - (iii) certain requirements for the purposes of section 56 of the *Electricity Supply Industry Act 1995*; and
- (b) classify certain work as being of minor environmental impact; and
- (c) are made consequentially on the repeal of the *Electricity Supply Industry Regulations 1996* under section 11 of the *Subordinate Legislation Act 1992*.

(3) *Medical Radiation Science Professionals Registration (Fees) Regulations 2008*

These regulations—

- (a) prescribe fees for the purposes of the *Medical Radiation Science Professionals Registration Act 2000*; and
- (b) increase the annual registration fee payable under that Act.

(4) Poisons Regulations 2008

These regulations make provision in respect of the prescription, possession, supply, manufacturing, storage, labelling, packaging and disposal of narcotic substances, poisons and restricted substances and miscellaneous related matters.

(5) Property Agents and Land Transactions Amendment Regulations (No. 2) 2008

These regulations amend the *Property Agents and Land Transactions Regulations 2006* by—

- (a) amending the Code of Conduct for property agents to allow a property agent to erect a sign on private property in certain circumstances; and
- (b) prescribing 17 December 2008 as the date from which the amendment takes effect.

(6) Traffic (Road Rules) Amendment (Tasman Speed-limits) Regulations 2008

These regulations amend the *Road Rules* by providing that, for a temporary period, the default speed limit for all drivers outside built-up areas in the Tasman municipality is 90 kilometres per hour on sealed roads and 80 kilometres per hour on unsealed roads.

(7) Vehicle and Traffic (Vehicle Standards) Amendment Regulations 2008

These regulations amend the *Vehicle and Traffic (Vehicle Standards) Regulations 2001* by –

- (a) revising certain regulations so they are consistent with changes to national vehicle standards; and
- (b) effecting minor statute law revision.
