TASMANIAN GOVERNMENT GAZETTE

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Evidence (Audio and Audio Visual Links) Regulations 2008

These regulations -

- (a) prescribe certain tribunals as Tasmanian courts for the purposes of the Evidence (Audio and Audio Visual Links) Act 1999; and
- (b) rescind the Evidence (Audio and Audio Visual Links) Regulations 1999.

(2) Gaming Control Amendment (Foreign Games Tax Rate) Regulations 2008

These regulations amend the *Gaming Control Regulations 2004* by prescribing the tax rate that is payable by a foreign games permit holder in respect of the sale in Tasmania of tickets in a foreign game for which there is no tax and revenue sharing agreement under section 150B of the *Gaming Control Act 1993*.

(3) Legal Profession (Prescribed Authorities) Regulations 2008

These regulations prescribe the Law Society of Tasmania as the prescribed authority for the purposes of certain provisions of the *Legal Profession Act 2007*.

(4) Fisheries (Infringement Notices) Amendment Regulations (No. 2) 2008

These regulations amend the Fisheries (Infringement Notices) Regulations 2001 by -

- (a) prescribing a further offence under the *Living Marine Resources Management Act 1995* for which an infringement notice may be issued; and
- (b) omitting certain infringement notice offences and penalties that are provided for in the Fisheries (Scalefish) Rules 2004 as amended.

(5) Proclamation under section 2 of the Water and Sewerage Corporations Act 2008

This proclamation fixes 9 July 2008 as the day on which the provisions of the *Water and Sewerage Corporations Act 2008* commence.

(6) Proclamation under section 2 of the Water and Sewerage Industry Act 2008

This proclamation fixes -

- (a) 9 July 2008 as the day on which the provisions of the *Water and Sewerage Industry Act 2008*, except section 30, commence; and
- (b) 1 July 2009 as the day on which section 30 of that Act commences.
