Office of the Premier Hobart, 11 July 2008

IT is hereby notified that His Excellency the Governor, acting with the advice of the Executive Council, has advised that, contrary to previous advice he had been given by the Executive Council, the Notice published in the Tasmanian Government Gazette (No. 20 854) on Monday 16 June 2008 at page 1061 titled Notice under Section 12 of the State Policies and Projects Act 1993 in relation to the declaration and notification of the Draft State Policy known as the Draft State Policy on the Protection of Agricultural Land 2008 has no effect in law because the said Draft State Policy had not been placed on public exhibition at the Resource Planning and Development Commission's office as required by section 6(2) of the State Policies and Projects Act 1993 either at the same time as the declaration and notification was made or at any time previously, and, being further advised that it was proper for him to do so, he has cancelled his signature by which he purported to make the declaration and notification. The said Notice is null and void.

STATE POLICIES AND PROJECTS ACT 1993

Notice Under Section 12

I, THE GOVERNOR in and over the State of Tasmania and its Dependencies in the Commonwealth of Australia, acting with the advice of the Executive Council, being satisfied on the recommendation of the Premier that it is necessary that the Draft State Policy known as the Draft State Policy on the *Protection of Agricultural Land 2007* and which is on public exhibition at the office of the Resource Planning and Development Commission (and a copy of which is set out in Schedule 1 to this notice) should come into operation as a State Policy without delay, by this my notice under section 12 of the *State Policies and Projects Act 1993* declare –

- (a) that the Draft State Policy known as the Draft State Policy on the Protection of Agricultural Land 2007 is to come into operation on a temporary basis as a State Policy on the day after the day on which the revocation, dated 16 June 2008, of the State Policy on the Protection of Agricultural Land 2000 (made on 4 September 2000 and notified in the Gazette on 4 September 2000 under section 11 of the State Policies and Projects Act 1993) takes effect: and
- (b) that any reference within the Draft State Policy on the Protection of Agricultural Land 2007 to the commencement of the Policy shall be taken to be the day on which the Draft State Policy commences operation by virtue of this notice; and
- (c) that the Acts Interpretation Act 1931 applies to the interpretation of this notice as if it were by-laws.
