GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Aboriginal Lands Regulations 2008*

These regulations –

- (a) prescribe guidelines for section 28 of the *Aboriginal Lands Act 1995*; and
- (b) prescribe the procedure for hearing an appeal under section 29 of that Act; and
- (c) are made consequentially on the repeal of the *Aboriginal Lands Regulations 1998* under section 11 of the *Subordinate Legislation Act 1992*.

- (2) Proclamation under section 2 of the *Environmental Management and Pollution Control Amendment (Environment Protection Authority) Act 2007*

This proclamation fixes 1 July 2008 as the day on which the *Environmental Management and Pollution Control Amendment (Environment Protection Authority) Act 2007* commences.

(3) *Liquor and Accommodation Amendment Regulations 2008*

These regulations amend the *Liquor and Accommodation Regulations 2003* by –

- (a) making minor changes to the categories of persons to whom liquor may be sold under a club licence; and
- (b) simplifying the provisions governing the grant of a club licence; and
- (c) bringing the title of the regulations into line with the title of the Act.

(4) *Local Government (Amendment of By-laws) Order 2008*

This order amends council by-laws to update infringement notice provisions in line with recent changes effected by the *Monetary Penalties Enforcement Act 2005*.

(5) *Major Infrastructure Development Approvals (Waddamana to Risdon Vale Electricity Transmission Line Project) Amendment Order 2008*

This order amends the *Major Infrastructure Development Approvals (Waddamana to Risdon Vale Electricity Transmission Line Project) Order 2004* consequent on the enactment of the *Environmental Management and Pollution Control Amendment (Environment Protection Authority) Act 2007* by –

- (a) replacing a reference to the Board of Environmental Management and Pollution Control with a reference to the Board of the Environment Protection Authority; and
- (b) omitting an obsolete reference to the Director of Environmental Management.

(6) Pollution of Waters by Oil and Noxious Substances Amendment Regulations 2008

These regulations amend the *Pollution of Waters by Oil and Noxious Substances Regulations 2007* consequent on the enactment of the *Environmental Management and Pollution Control Amendment (Environment Protection Authority) Act 2007* by replacing a reference to the office of Director of Environmental Management with a reference to the office of Director, Environment Protection Authority.

(7) Public Interest Disclosures Amendment Regulations 2008

These regulations amend the *Public Interest Disclosures Regulations 2003* consequent on the enactment of the *Environmental Management and Pollution Control Amendment (Environment Protection Authority) Act 2007* by replacing a reference to the office of Director of Environmental Management with a reference to the office of Director, Environment Protection Authority.

(8) Radiation Protection Amendment Regulations 2008

These regulations amend the *Radiation Protection Regulations 2006* consequent on the enactment of the *Environmental Management and Pollution Control Amendment (Environment Protection Authority) Act 2007* by replacing a reference to the Director of Environmental Management with a reference to the Director, Environment Protection Authority.

(9) Proclamation under section 2 of the Road Safety (Alcohol and Drugs) Amendment Act 2008

This proclamation fixes 4 June 2008 as the day on which the *Road Safety (Alcohol and Drugs) Amendment Act 2008* commences.

(10) Taxation Administration Amendment Regulations 2008

These regulations amend the *Taxation Administration Regulations 2000* by specifying certain persons to be prescribed persons for the purposes of section 77(1)(e)(x) of the *Taxation Administration Act 1997*.
