GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Chiropractors and Osteopaths Registration (Fees) Amendment Regulations 2008

These regulations amend the *Chiropractors and Osteopaths Registration (Fees) Regulations 2006* by increasing the application for registration fee and the annual registration fee payable under the *Chiropractors and Osteopaths Registration Act 1997*.

(2) Traffic (Electronic Billboards) Regulations 2008

These regulations prescribe certain devices used by police officers for traffic management, road safety or law enforcement purposes as devices that are not taken to be electronic billboards for the purposes of Part VIII of the *Traffic Act 1925*.

(3) Magistrates Court (Civil Division) Amendment Rules 2008

These rules of court amend the *Magistrates Court (Civil Division) Rules 1998* by –

- (a) providing that, in any proceeding, a body of persons may be represented by a natural person; and
- (b) adjusting, in line with the Court's expanded jurisdiction, the scale of "costs to be endorsed on process" to accommodate claims over \$20 000.
