### WORKPLACE HEALTH AND SAFETY ACT 1995

I HEREBY give notice, pursuant to s22(5) of the *Workplace Health and Safety Act 1995*, of the approval on 8 September 2008 by the former Minister for Planning and Workplace Relations, David Bartlett, of a code of practice, namely the Applicable Standards for Underground Mining and Associated Operations ("the Code").

The Code takes into account comments received during the public comment period.

The purpose of the Code is to provide guidance to responsible persons at underground mines and associated facilities on how to meet their general duty of care responsibilities under the *Workplace Health and Safety Act 1995* through and in relation to:

- Safety management systems;
- Risk management;
- · Safety requirements for conveyors; and
- Guidance on the application of exposure standards for atmospheric contaminants.

Industry is not required to comply with the Code, but may be asked to demonstrate that the system chosen is equal to, or better than, the approved Code of Practice.
