LIVING MARINE RESOURCES MANAGEMENT ACT 1995

PUBLIC NOTICE

Setting of Total Allowable Catch (TAC), determining the parts and portions from which the TAC is to be taken for the Commercial Banded Morwong Fishery (Cheilodactylus Spectabilis).

I, DAVID LLEWELLYN, the Minister administering the *Living Marine Resources Management Act 1995*, pursuant to section 94 of that Act, hereby:

1. Specify the quota period for the commercial banded morwong fishery to be 1 October 2008 and expiring 28 February 2009;
2. Set the Total Allowable Catch for that period for the commercial banded morwong fishery at 25 tonnes of banded morwong; and,
3. Determine that the part of the commercial banded morwong fishery from which the total allowable catch is to be taken is: the "TAC area" as defined in the *Fisheries (Scalefish) Rules 2004*.
