#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Wildlife Amendment Regulations 2008

These regulations amend the *Wildlife Regulations 1999* by prescribing the fresh water turtle to be a restricted animal for the purposes of section 32 of the *Nature Conservation Act 2002*.

(2) Passenger Transport Amendment (Community Transport) Regulations 2008

These regulations amend the Passenger Transport Regulations 2000 by -

- (a) extending, until 1 January 2010, the period of the temporary exemption from registration under the *Passenger Transport Act 1997* for small passenger vehicles that are used to provide community transport services; and
- (b) revising the circumstances in which the Transport Commission may exempt community transport service providers from the need to be accredited under that Act.
  - (3) Supreme Court (Corporations) Rules 2008

These Rules of Court -

- (a) adopt, with minor modifications, the *Federal Court (Corporations) Rules 2000* of the Commonwealth as rules of the Supreme Court of Tasmania; and
- (b) rescind the Supreme Court (Corporations) Rules 2000 and related amendment rules.
- (4) Vehicle and Traffic (Driver Licensing and Vehicle Registration) Amendment (Community Transport) Regulations 2008
  These regulations amend the Vehicle and Traffic (Driver Licensing and Vehicle Registration) Regulations 2000 by
  - (a) extending, until 1 January 2010, the period of the temporary exemption for certain driving instructors and drivers providing community transport services from the requirement to hold an ancillary certificate under the *Vehicle* and *Traffic Act* 1999; and
  - (b) revising the scope of that exemption for drivers providing community transport services.
