## GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Fisheries (Infringement Notices) Amendment Regulations 2009

These regulations amend the Fisheries (Infringement Notices) Regulations 2001 by -

- (a) prescribing the offences under the Fisheries Rules 2009 for which infringement notices may be issued; and
- (b) prescribing the penalties payable for those offences; and
- (c) removing the infringement notice offences and penalties relating to the superseded *Fisheries Rules 1999* and the *Fisheries (Abalone) Rules 2000*.
