Proposed Mine Safety Legislation

THE DEPARTMENT of Justice invites comment on the Regulatory Impact Statement (RIS) on 'Mine Safety in Tasmania, Proposal to Amend the *Workplace Health and Safety Act 1995*.'

The RIS is accompanied by an Information Paper that provides further detail on the proposals.

The proposed Act amendments will add provisions applicable to mining, with the objectives to:

- secure the health and safety of persons at mines and persons who may be affected by mining operations;
- ensure identification of hazards, assessment of risk of injury or harm, and elimination, management and reduction of such risks;

- facilitate effective management of occupational health and safety; facilitate and foster cooperation and consultation between operators, employers and workers; and foster continuous improvement; and
- ensure effective provisions for appropriate emergency management, preparedness and response are developed and maintained at mines.


