In accordance with the provisions of the *Rules Publication Act 1953*, notice is given of the making of the following statutory rules:—

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *National Parks and Reserved Land Regulations 2009*

These regulations, which replace the *National Parks and Reserved Land Regulations 1999* consequent on their repeal under the *Subordinate Legislation Act 1992*—

- (a) provide for the management of reserved land and for the imposition of charges in relation to the management of reserved land in certain circumstances; and
- (b) prescribe offences and penalties relating to infringement notices and vehicle infringement notices.

(2) *Public Trustee Regulations 2009*

These regulations—

- (a) prescribe a range of matters for the purposes of the *Public Trustee Act 1930*, including maximum fees, commissions, remunerations and charges; and
- (b) are made consequentially on the repeal of the *Public Trustee Regulations 1999* under section 11 of the *Subordinate Legislation Act 1992*.
