ANIMAL (BRANDS AND MOVEMENT) ACT 1984

Notice Of Requirement For Permanent Identification Of Livestock Section 22FA

I, DAVID EDWARD LLEWELLYN, being and as the Minister for Primary Industries and Water, pursuant to s22FA of the *Animal (Brands and Movement) Act 1984* and s22 of the *Acts Interpretation Act 1931*, hereby repeal the notice of 5 June 2006 and published in the *Gazette* on 19 July 2006 and make the following notice:—

In accordance with the provisions of section 22FA of the *Animal (Brands and Movement) Act 1984*, I hereby require that from 1 January 2009 a person in charge of any sheep must ensure a permanent identification device is attached to, or inserted in each sheep as follows:—

- a) all sheep must be identified with a permanent identification device identifying the property of residence before leaving the property: unless
- b) the sheep are already identified with a permanent identification device from a previous property and a vendor declaration recording all the property identification codes (PICs) from the permanent identification devices in the consignment is supplied to the receiver of the sheep and a copy is kept by both parties for 7 years.

If a person, who is required to identify sheep in accordance with this notice, is genuinely unable to attach or insert a permanent identification device identifying the property of residence, he or she must identify those sheep with emergency identification devices obtained and applied through a scheme approved by the Registrar of Brands.

 - (a) Venue Operating Procedures Gaming Machines and Keno (including any supplementary procedures);
 - (b) Venue Operating Procedures Gaming Machine Jackpots (including any supplementary procedures);
 - (c) Rules for Keno;
 - (d) Network Gaming Central Monitoring and Control System Operating Procedures (including any supplementary procedures);
 - (e) Network Gaming Keno Central Computer System Operating Procedures (including any supplementary procedures);
 - (f) Casino Internal Control and Accounting Manual (including any supplementary procedures) approved for Tasmanian Country Club-Casino Proprietary Limited and Australian National Hotels Pty Limited;

- (g) Accounting and Internal Control Policies and Procedures Manual (including any supplementary procedures) approved for Admirals Casino Pty Ltd: and/or
- (h) Internal Control and Accounting Manual (including any supplementary procedures) approved for Betting Exchange operator Betfair Pty Ltd.
