GIANT CRAB SIZE LIMIT EXEMPTION INSTRUMENT

I, DAVID LLEWELLYN, Minister administering the *Living Marine Resources Management Act 1995*, pursuant to Section 11 of that Act, hereby exempt all persons from rule 14 (1) (a) of the *Fisheries (Giant Crab) Rules 2006* subject to the following conditions:

- (1) A person must not take, buy, sell or be in possession of a **female** giant crab that has a carapace less than 150 millimetres long.
- (2) A person must not take, buy, sell or be in possession of a **male** giant crab that has a carapace less than 140 millimetres long.

This exemption takes effect on the 1 March 2009 and remains in force for a period of 12 months.
