LIVING MARINE RESOURCES MANAGEMENT ACT 1995

Fisheries (Biosecurity) Order No. 1, 2009

I MAKE the following Order under section 270 of the *Living Marine Resources Management Act 1995* issuing directions aimed at preventing the introduction into State waters of a harmful disease.

Short title

1. This order may be cited as the *Fisheries (Biosecurity) Order No. 1, 2009*.

Specification

2. This Order is made in respect of the disease *Abalone Viral Ganglioneuritis* and is aimed at preventing the introduction and spread of this disease in State waters.

Directions Issued

3. (1) That the holder of a fishing licence (abalone dive) intending to take, taking and possessing abalone from the Northern Bass Strait Region must comply with the *Specifications for Commercial Abalone Fishing or Processing in Defined Waters* as provided for under Section 270 (3) (d) of the *Living Marine Resources Management Act 1995*.
- (2) That the Master of a fishing vessel who intends to possess or possessing abalone from the Northern Bass Strait Region must comply with the *Specifications for Commercial Abalone Fishing or Processing in Defined Waters* as provided for under Section 270 (3) (d) of the *Living Marine Resources Management Act 1995*.
- (3) That the holder of a Fish Processing Licence authorised to process abalone who intends to possess or possessing abalone from the Northern Bass Strait Region must comply with the *Specifications for Commercial Abalone Fishing or Processing in Defined Waters* as provided for under Section 270 (3) (d) of the *Living Marine Resources Management Act 1995*.

Interpretation

4. Northern Bass Strait Region is defined to mean: those State waters bounded in the north by the line of latitude 39° 12' South, in the east by the line of longitude 147° 35' East, in the south by the line of latitude 40° 20' South and in the west by the line of longitude 146° East.
5. Expressions in this order have the same meaning as in the *Living Marine Resources Management Act 1995* and the *Fisheries (Abalone) Rules 2000*.

- (b) decreasing the fee payable on the commencement of proceedings for admission to the legal profession and increasing certain other fees payable in respect of proceedings; and
- (c) making minor consequential and miscellaneous amendments.

(2) *Supreme Court Amendment (Wills) Rules 2009*

These Rules of Court amend the *Supreme Court Rules 2000* to –

- (a) provide for certain proceedings in the Supreme Court in respect of wills to be commenced by application rather than by writ; and
- (b) revise the procedures for such applications consequent on the commencement of the *Wills Act 2008*.

(3) *Water Management (Well Works Permit Exemption) Order (No. 2) 2009*

This order –

- (a) revokes the *Water Management (Well Works Permit Exemption) Order 2009*; and
- (b) declares that a well works permit is not required for certain classes of well works.

(4) *Justices Amendment Rules 2009*

These rules of court amend the *Justices Rules 2003* by –

- (a) empowering justices (who are not magistrates) to revoke family violence orders when exercising jurisdiction under the *Family Violence Act 2004*; and
- (b) removing from rule 6 a provision that is inconsistent with the *Justices Act 1959*.
