## Occupational Licensing

### OCCUPATIONAL LICENSING ACT 2005

#### OCCUPATIONAL LICENSING (ELECTRICAL INFRASTRUCTURE) INSURANCE NOTICE 2009

I, ROBERT LINDSAY PEARCE, Administrator of Occupational Licensing, make the following Notice under section 27(1) of the *Occupational Licensing Act 2005*.

#### ***PART 1 – PRELIMINARY***

**1. Title of this Notice**

This Notice may be cited as the “Occupational Licensing (Electrical Infrastructure) Insurance Notice 2009”.

**2. Purpose of this Notice**

This Notice specifies the insurance required to be held by licence holders who undertake prescribed work on electrical infrastructure owned by electricity entities.

**3. Authorising provision**

This Notice is made under section 27(1) of the *Occupational Licensing Act 2005*.

**4. Commencement**

This Notice takes effect on 19 June 2009.

**5. Application of *Acts Interpretation Act 1931***

The *Acts Interpretation Act 1931* applies to this Notice.

**6. Definitions**

In this Notice –

“**electrical infrastructure**” has the meaning given it by the *Occupational Licensing (Electrical Work) Regulations 2008*;

“**electricity entity**” has the meaning given it by the *Occupational Licensing (Electrical Work) Regulations 2008*; and

“**licence holder**” means a person holding a licence under the *Occupational Licensing Act 2005*.

**7. Scope of coverage**

This notice removes the requirement for licence holders to have insurance to pay for the cost of rectifying any defective prescribed work where it has been performed on electrical infrastructure that is owned by an electricity entity.

**8. Application of Notice**

Clause 11(a) of the Occupational Licensing General Insurance Notice 2008 does not apply where a licence holder is performing prescribed work on electrical infrastructure that is owned by an electricity entity.
