# Marine Safety

## TASMANIA

### MARINE AND SAFETY (VESSEL SAFETY STANDARDS) AMENDMENT BY-LAWS 2009

THE Marine and Safety Authority makes the following by-laws under section 42 of the *Marine and Safety Authority Act 1997*.

#### 1. Short title

These by-laws may be cited as the *Marine and Safety (Vessel Safety Standards) Amendment By-Laws 2009*.

#### 2. Commencement

These by-laws take effect on the day on which they are published in the *Gazette*.

#### 3. Principal By-laws

In these by-laws, the *Marine and Safety (Vessel Safety Standards) By-laws 2000* are referred to as the Principal By-laws.

#### 4. Clause 3 amended

Clause 3 of the Principal By-laws is amended as follows:—

- (a) by inserting the following definition after the definition of “accredited organisation”:  

“**anchoring system**” has the same meaning as in Part C, Subsection 7D of the NSCV;
- (b) by inserting the following definition after the definition of “existing surveyed vessel”:  

“**fast craft**” has the same meaning as in Part F, Subsection 1A of the NSCV;

#### 5. Clause 44 substituted

Clause 44 of the Principal By-laws is rescinded and the following clauses are substituted:

##### 44. General

The structural design of a vessel, other than a fast craft, is taken to meet the requirements of this Division if that structural design meets the requirements of the relevant provisions of Part C, Section 3 of the NSCV.

##### 44A. Fast Craft

(1) The construction of a fast craft is taken to meet the requirements of this Division if that construction meets the requirements of—

- (a) the relevant provisions of Part C, Section 3 of the NSCV; and
  - (b) in the case of —
    - (i) a fast craft to which Part F, Subsection 1B of the NSCV applies, the relevant provisions of that Subsection 1B; or
    - (ii) a fast craft to which Part F, Subsection 1C of the NSCV applies, the relevant provisions of that Subsection 1C.
- (2) The design and operation of a fast craft is taken to meet the requirements of this Division if that design and operation meets the requirements of —
- (a) in the case of a fast craft to which Part F, Subsection 1B of the NSCV applies, the relevant provisions of that Subsection 1B; or
  - (b) in the case of a fast craft to which Part F, Subsection 1C of the NSCV applies, the relevant provisions of that Subsection 1C.

#### 6. Clause 58A inserted

The Principal By-laws are amended by inserting the following clause after clause 58:

##### 58A. Anchoring design and equipment

The anchoring system on a vessel is to meet the requirements of the relevant provisions of Part C, Subsection 7D of the NSCV.

#### 7. Clause 63 substituted

Clause 63 of the Principal By-laws is rescinded and the following clause is substituted:

##### 63. General

The design, construction and installation of machinery in a vessel is taken to meet the requirements of this Division if that design, construction and installation meets the requirements of the relevant provisions of Part C, Subsection 5A of the NSCV.

#### 8. Clause 69 substituted

Clause 69 of the Principal By-laws is rescinded and the following clause is substituted:

##### 69. LP Gas systems

- (1) The design of a system on a vessel for appliances using LP Gas is to meet the requirements of the relevant provisions of Part C, Subsection 5C of the NSCV.
- (2) The design of a system on a vessel for engines using LP Gas is to meet the requirements of the relevant provisions of Part C, Subsection 5D of the NSCV.

#### 9. Clause 79A substituted

Clause 79A of the Principal By-laws is rescinded and the following clause is substituted:

##### 79A. Compliance of electrical systems

An electrical system, on a vessel, is taken to meet the requirements of this Division if that electrical system meets the requirements of the relevant provisions of Part C, Subsection 5B of the NSCV.

#### 10. Clause 95 substituted

Clause 95 of the Principal By-laws is rescinded and the following clause is substituted:

##### 95. General

The design of a fixed fire protection system on a vessel is to meet the requirements of the relevant provisions of Part C, Subsection 4 of the NSCV.

#### 11. Clause 172 Amended

Clause 172 of the Principal By-laws is amended by omitting paragraphs (a) and (b) of subsection (1) and substituting the following paragraphs:

- (a) AS 1799
- (b) Part C, Subsection 6A of the NSCV;

#### 12. Clause 173 amended

Clause 173 of the Principal By-laws is amended by omitting paragraph (a) of subsection (1) and substituting the following paragraph:

- (a) Part C, Subsection 6A of the NSCV;
