GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Gas (Safety) Amendment Regulations 2009*

These regulations amend the *Gas (Safety) Regulations 2002* by—

- (a) updating the standards and codes that apply in certain circumstances; and
- (b) requiring certain gas fitting work to be commissioned; and
- (c) updating the requirements for gas installations and gas fitting work; and
- (d) making provision for automotive gas fitting work; and
- (e) effecting minor statute law revision.
