This order places restrictions on the sale of prams and strollers.

(4) *Fisheries Rules 2009*

These rules provide for –

- (a) the management of Tasmanian fisheries in State Waters; and
- (b) licences for those fisheries; and
- (c) reporting and other requirements relating to those fisheries; and
- (d) the rescission of previous rules relating to those fisheries.
