## Living Marine Resources

### *Fisheries (Biosecurity) Order (No. 3) 2009*

I, DAVID LLEWELLYN, Minister for Primary Industries and Water, make the following Order under Section 270 of the *Living Marine Resources Management Act 1995* in relation to issuing directions aimed at preventing the introduction or spread in State waters of a harmful disease.

#### Short title

1.—This Order may be cited as the *Fisheries (Biosecurity) Order (No. 3) 2009*.

#### Specification

2.—This Order is made in respect of the disease *Abalone Viral Ganglioneuritis* and is aimed at preventing the introduction or spread of the disease in State waters or any other jurisdiction.

#### Directions Issued

3.—That no part of any abalone (*Genus Haliotis*) may be used as bait in State waters, on and from the date this order is published in the *Tasmanian Government Gazette* for a period of 12 months.

#### Interpretation

4.—Expressions in this Order have the same meaning as in the *Living Marine Resources Management Act 1995*.
