I, THE Lieutenant-Governor in and over the State of Tasmania and its Dependencies in the Commonwealth of Australia, acting with the advice of the Executive Council, by this my proclamation made under sections 15 and 17 of the *Forestry Act 1920*—

- (a) declare that that part of the land entered in the Register of Multiple Use Forest Land under section 132 of the *Public Land (Administration and Forests) Act* 1991, and specified in Item 1 of Schedule 1 to this proclamation be deleted from that register; and
- (b) revoke the dedication as State forest of the land referred to in paragraph (a); and
- (c) declare that this Proclamation takes effect on the day on which its making is notified in the *Tasmanian* Government Gazette.

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Electricity Supply Industry Amendment Regulations 2009

These regulations amend the Electricity Supply Industry Regulations 2008 to -

- (a) prescribe the fee payable for a licence under Division 1 of Part 3 of the Electricity Supply Industry Act 1995; and
- (b) provide that a licence is not required for
 - (i) the retailing of electricity to another retailer licensed under that Act; or
 - (ii) the retailing of electricity generated by certain specified power stations of historic significance; or
 - (iii) the generation of electricity by all generators with a capacity of 5 megawatts or less.
 - (2) Poisons Amendment Regulations 2009

These regulations amend the Poisons Regulations 2008 by -

- (a) providing a new circumstance for which the Minister for Health may authorise a registered nurse to possess or supply a restricted or narcotic substance; and
- (b) updating regulation 74(c) consequentially on the enactment of the *Dangerous Substances (Safe Handling) Act 2005*; and
- (c) adding homatropine to the list of prescribed class 1 substances for the purposes of section 38(1) of the *Poisons Act* 1971
 - (3) Security and Investigations Agents Amendment Regulations 2009

These regulations amend the Security and Investigations Agents Regulations 2005 by prescribing additional offences for which an infringement notice may be issued.

(4) Supreme Court Amendment (Discovery) Rules 2009

These Rules of Court amend the *Supreme Court Rules 2000* so as to provide that the definition of "document" in Division 1 of Part 13, which relates to discovery and interrogatories, applies to the whole of that Part.
