### REDUCING RURAL DEFAULT SPEED LIMITS IN TASMANIA

THE Road Safety Advisory Council is considering the issue of safer rural speeds in the development of the Second Action Plan under the Tasmanian Road Safety Strategy.

In accordance with the *Subordinate Legislation Act 1992* a Regulatory Impact Statement (RIS) has been developed on the proposal to reduce default speed limits in Tasmania as follows:

A reduction in the rural default speed limit on sealed rural roads from 100km/h to 90km/h, whilst retaining 100km/h on higher standard rural roads; and

A reduction in the rural default speed limit on unsealed (gravel) roads from 100km/h to 80km/h.

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Proclamation under section 2 of the Australian Consumer Law (Tasmania) Act 2010

This proclamation fixes 1 January 2011 as the day on which the provisions of the *Australian Consumer Law (Tasmania) Act 2010*, apart from sections 1 and 2 and Parts 6 and 7 (which provisions commenced on Royal Assent), commence.

(2) Proclamation under section 2 of the Electronic Transactions Amendment Act 2010

This proclamation fixes 1 January 2011 as the day on which the provisions of the *Electronic Transactions Amendment Act 2010* commence.

(3) Environmental Management and Pollution Control (Environmental Infringement Notices) Amendment Regulations (No. 3) 2010

These regulations amend the Environmental Management and Pollution Control (Environmental Infringement Notices) Regulations 2006 by updating the table of infringement notice offences and penalties for waste management offences consequent on the making of the Environmental Management and Pollution Control (Waste Management) Regulations 2010.

(4) Proclamation under section 2 of the Evidence Amendment Act 2010

This proclamation fixes 1 January 2011 as the day on which the provisions of the Evidence Amendment Act 2010 commence.

(5) Forensic Procedures Regulations 2010

These regulations prescribe corresponding laws for the purposes of the *Forensic Procedures Act 2000* and rescind the *Forensic Procedures Regulations 2001* and certain other regulations.

(6) Health (Fees) Amendment Regulations (No. 2) 2010

These regulations amend the *Health (Fees) Regulations 2007* by increasing the fees for pharmaceutical items that are payable by or on behalf of non-nursing-home-type patients who are non-admitted patients in public hospitals.

(7) Proclamation under the Intestacy Act 2010

This proclamation fixes 1 January 2011 as the day on which the *Intestacy Act 2010* commences.

(8) Proclamation under section 2(2) of the Justice and Related Legislation (Further Miscellaneous Amendments) Act 2009

This proclamation fixes 1 January 2011 as the day on which Part 10 of the *Justice and Related Legislation (Further Miscellaneous Amendments) Act 2009* commences.

(9) Local Government (Copping Refuse Disposal Site Joint Authority) Order 2010

This order declares the Copping Refuse Disposal Site Joint Authority to be an authority to which Part 3A of the *Local Government Act 1993* applies.

(10) Proclamation under section 2 of the Personal Property Securities (Commonwealth Powers) Act 2010

This proclamation fixes 1 January 2011 as the day on which the *Personal Property Securities (Commonwealth Powers) Act 2010*, except section 8(2) and (3) of that Act, commences.

(11) Proclamation under section 2 of the Pharmacists Registration Amendment Act 2010

This proclamation fixes 1 February 2011 as the day on which the Pharmacists Registration Amendment Act 2010 commences.

(12) Pharmacy Control (Fees) Regulations 2010

These regulations prescribe fees for the purposes of the Pharmacy Control Act 2001.

(13) Proclamation under section 2 of the Poisons Amendment (Midwives) Act 2010

This proclamation fixes 1 January 2011 as the day on which the Poisons Amendment (Midwives) Act 2010 commences.

(14) Poisons Amendment (Midwives) Regulations 2010

These regulations amend the Poisons Regulations 2008 to enable midwives to -

- (a) administer, supply and prescribe certain restricted substances; and
- (b) administer certain narcotic substances.

(15) Police Powers (Assumed Identities) (Corresponding Laws) Regulations 2010

These regulations declare certain laws of other jurisdictions to correspond to the Police Powers (Assumed Identities) Act 2006.

(16) Police Powers (Controlled Operations) (Corresponding Laws) Regulations 2010

These regulations declare certain laws of other jurisdictions to correspond to the Police Powers (Controlled Operations) Act 2006.

(17) Police Powers (Surveillance Devices) (Corresponding Laws) Regulations 2010

These regulations declare certain laws of other jurisdictions to correspond to the Police Powers (Surveillance Devices) Act 2006.

(18) Proclamation under section 2 of the Trustee Companies Amendment Act 2010

This proclamation fixes 1 January 2011 as the day on which the provisions of the Trustee Companies Amendment Act 2010 commence.

(19) Witness (Identity Protection) (Corresponding Laws) Regulations 2010

These regulations declare certain laws of other jurisdictions to correspond to the Witness (Identity Protection) Act 2006.

(20) Probate Amendment Rules 2010

These Rules of Court amend the *Probate Rules 1936* by updating who has the right to a grant of administration if a person dies intestate.

(21) Supreme Court Amendment Rules (No. 2) 2010

These Rules of Court amend the *Supreme Court Rules 2000* by providing that proceedings under the *Intestacy Act 2010* are to be commenced by application to a judge in chambers.

(22) Poisons List Amendment Order (No. 3) 2010

This order amends the *Poisons List Order 2001* by incorporating changes recommended by the National Drugs and Poisons Schedule Committee in the Standard for the Uniform Scheduling of Medicines and Poisons No. 1, Amendment No. 1.
