### LIVING MARINE RESOURCES MANAGEMENT ACT 1995

#### Fisheries (Biosecurity) Order (No. 1) 2010

I MAKE the following Order under section 270 of the *Living Marine Resources Management Act 1995* issuing directions aimed at preventing the introduction into State waters of a harmful disease.

### Short title

1. - This order may be cited as the Fisheries (Biosecurity) Order (No. 1) 2010.

#### Specification

2. - This Order is made in respect of the disease *Abalone Viral Ganglioneuritis* and is aimed at preventing the introduction and spread of this disease in State waters.

#### **Directions Issued**

3. - (1) That the holder of a fishing licence (abalone dive) intending to take, taking and possessing abalone from the Northern Bass Strait Region must comply with the *Specifications for Commercial Abalone Fishing or Processing in Defined Waters* as provided for under Section 270 (3) (d) of the *Living Marine Resources Management Act 1995*.

(2) That the Master of a fishing vessel who intends to possess or possessing abalone from the Northern Bass Strait Region must comply with the *Specifications for Commercial Abalone Fishing or Processing in Defined Waters* as provided for under Section 270 (3) (d) of the *Living Marine Resources Management Act 1995.* 

(3) That the holder of a Fish Processing Licence authorised to process abalone who intends to possess or possessing abalone from the Northern Bass Strait Region must comply with the *Specifications for Commercial Abalone Fishing or Processing in Defined Waters* as provided for under Section 270 (3) (d) of the *Living Marine Resources Management Act 1995*.

#### Interpretation

4.- Northern Bass Strait Region is defined to mean: those State waters bounded in the north by the line of latitude  $39^{\circ}$  12' South, in the east by the line of longitude 147° 35' East, in the south by the line of latitude  $40^{\circ}$  20' South and in the west by the line of longitude 146° East.

5.- Expressions in this order have the same meaning as in the *Living Marine Resources Management Act 1995* and the *Fisheries (Abalone) Rules 2009.*
