ENVIRONMENTAL MANAGEMENT AND POLLUTION CONTROL (UNDERGROUND PETROLEUM STORAGE SYSTEMS) REGULATIONS 2010

NOTICE OF GUIDELINES

NOTICE is hereby given of the issue of an EPA guideline titled Underground Petroleum Storage Systems: Decommissioning Assessment Report Requirements under regulation 42(1) of the Environmental Management and Pollution Control (Underground Petroleum Storage Systems) Regulations 2010 (UPSS Regulations).

The guideline sets out the information that must be provided, as a minimum, in an assessment report required under regulations 30(7)(d) or 31(2)(d) in relation to the decommissioning of active and abandoned underground petroleum storage systems. This includes requiring that the assessment report conclude whether the site is a contaminated site (as defined in section 74A(2) Environmental Management and Pollution Control Act 1994) based on the level of contamination remaining on the site in the vicinity of the storage system.
