I, The HONOURABLE PETER GEORGE UNDERWOOD, Companion of the Order of Australia, Governor in and over the State of Tasmania and its Dependencies in the Commonwealth of Australia, in pursuance of the power and authority in me vested by the *Senate Elections Act 1935*, do, by this proclamation, fix the dates set forth in the schedule hereto as the date for the issue of the writ, the date for the close of the roll of electors for the election, the day of nomination, the date for the polling and the date on or before which the Writ shall be returned, respectively, for the purposes of an election of Senators for the State of Tasmania.
