GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Proclamation under section 9(1) of the Corrections Act 1997

This proclamation declares the Hayes Prison Farm (previously known as the Kilderry Farm Gaol) to be a prison.

(2) Dog Control Regulations 2010

These regulations -

- (a) prescribe certain details for the purposes of the Dog Control Act 2000; and
- (b) prescribe certain offences as offences for which an infringement notice may be issued; and
- (c) rescind the Dog Control Regulations 2001.
 - (3) Proclamation under section 2 of the Workers Rehabilitation and Compensation Amendment Act 2009

This proclamation fixes 1 July 2010 as the day on which the provisions of the Workers Rehabilitation and Compensation Amendment Act 2009 commence.

(4) Poisons (Exempted Public Institutions) Order 2010

This order declares the Police Service and the Department of Police and Emergency Management to be -

- (a) public institutions for the purposes of the Poisons Act 1971; and
- (b) exempted public institutions for the purposes of section 55 of that Act.
