- Great Oyster Bay (as defined in Schedule 2 of the *Fisheries (Scalefish) Rules 2004*); and
- All east coast Tasmanian waters between an imaginary straight line running due east through Lemon Rock (42° 11' 44" South [GDA 94]) to the outer limit of State waters and an imaginary straight line running due east from the northern end of Marion Beach (42° 46' 06" South [GDA 94]) to the outer limit of State waters.

Closed season is from 15 October 2010 to 14 November 2010 inclusive.

- from 15 November 2010 to 31 December 2010, inclusive;

where State waters of abalone sub-block 31A is defined to mean:- State waters off the north-east coast of Tasmania bounded in the north by an imaginary line starting from the northern side of the mouth of the Great Musselroe River at Musselroe Bay, running due west for 100 metres, following the shoreline 100 metres from shore to the northernmost tip of Musselroe Point, running due north until intersection with the line of latitude 40° 48' 00" South and running due east to the outer limit of State waters and bounded in the south by the line of latitude 40° 59' 42.594" South;
