NOTICE is hereby given of the approval of an EPA protocol titled *Underground Petroleum Storage Systems: Statistical Inventory Reconciliation Analysis* under regulation 11(6) of the *Environmental Management and Pollution Control (Underground Petroleum Storage Systems) Regulations 2010* (UPSS Regulations).

The EPA protocol sets out the test procedure for system verification that an independent third party must use to verify that the Statistical Inventory Reconciliation Analysis (SIRA) method being undertaken can meet the performance standards specified in regulation 11(5) of the UPSS Regulations. SIRA involves the statistical analysis of delivery, usage and dip data to determine whether a loss of 0.76 litres/hour or more of petroleum has occurred.

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Sale of Hazardous Goods (Children's Toys) Order 2010*

This order places restrictions on the sale of children's toys and finger paints.

(2) *Sale of Hazardous Goods (Flotation and Aquatic Toys) Order 2010*

This order places restrictions on the sale of flotation toys and aquatic toys.

(3) *Sale of Hazardous Goods (Swimming and Flotation Aids) Order 2010*

This order places restrictions on the sale of children's swimming and flotation aids for use in water familiarization and swimming tuition.
